A BILL ENTITLED

1 AN ACT concerning

2 **Transparency Act of 2019**

3 FOR the purpose of requiring the General Assembly to make available to the public certain
4 video streaming of certain meetings of the Senate of Maryland, the House of
5 Delegates of Maryland, and certain standing committees of the General Assembly;
6 and generally relating to video streaming of meetings of the General Assembly.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

HOUSE BILL 232

- 1 (a) In this title the following words have the meanings indicated.
- 2 (b) “House” means the House of Delegates of Maryland.
- 3 (d) “Senate” means the Senate of Maryland.
- 4 (f) “Standing committee” means:
- 5 (1) a standing committee of the Senate, as set forth in the Senate rules; or
- 6 (2) a standing committee of the House, as set forth in the House rules.

7 **2-1805.**

8 **THE GENERAL ASSEMBLY SHALL MAKE AVAILABLE TO THE PUBLIC LIVE AND**
9 **ARCHIVED VIDEO STREAMING OF EACH MEETING OF THE SENATE, THE HOUSE, AND**
10 **A STANDING COMMITTEE, INCLUDING ANY HEARINGS OR VOTING SESSIONS HELD BY**
11 **A STANDING COMMITTEE.**

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2019.
