## 1 Article - Criminal Law 2 11 - 303. 3 (a) (1) A person may not knowingly: 4 (i) take or cause another to be taken to any place for prostitution; place, cause to be placed, or harbor another in any place for 5 (ii) 6 prostitution; 7 (iii) persuade, induce, entice, or encourage another to be taken to or 8 placed in any place for prostitution; 9 receive consideration to procure for or place in a house of prostitution or elsewhere another with the intent of causing the other to engage in 10 11 prostitution or assignation; 12 engage in a device, scheme, or continuing course of conduct (v) 13 intended to cause another to believe that if the other did not take part in a sexually explicit performance, the other or a third person would suffer physical restraint or serious physical 14 15 harm; or 16 (vi) destroy, conceal, remove, confiscate, or possess an actual or 17 purported passport, immigration document, or government identification document of another while otherwise violating or attempting to violate this subsection. 18 19 A parent, guardian, or person who has permanent or temporary care or 20 custody or responsibility for supervision of another may not consent to the taking or 21detention of the other for prostitution. 22A person may not violate subsection (a) of this section involving a victim (b) (1)23who is a minor. 24 A person may not knowingly take or detain another with the intent to 25use force, threat, coercion, or fraud to compel the other to marry the person or a third person or perform a sexual act, sexual contact, or vaginal intercourse. 26 27 A person who violates subsection (b) of this section is guilty of the felony of human trafficking and on conviction is subject to imprisonment not exceeding 25 years 28 29 or a fine not exceeding \$15,000 or both. 30 14–101.
