Because of another person's or group's race, color, religious beliefs, sexual orientation, gender, disability, or national origin, or because another person or group is homeless, a person may not:

- 4 (1) (i) commit a crime for attempt **OR THREATEN** to commit a crime against that person or group;
- 6 (ii) [damage the real or personal property of that person or group;
- 7 (iii)] deface, damage, or destroy {\frac{1}{2}}, or attempt OR THREATEN to deface, 8 damage, or destroy {\frac{1}{2}} the real or personal property of that person or group; or
- 9 [(iv)] (III) burn for attempt OR THREATEN to burn an object on the 10 real or personal property of that person or group; or
- 11 (2) commit a violation of item (1) of this section that:
- 12 (i) except as provided in item (ii) of this item, involves a separate 13 crime that is a felony; or
- 14 (ii) results in the death of a victim.

A person may not deface, damage, or destroy, **fattempt OR THREATEN* to deface, damage, or destroy, **for attempt OR THREATEN* to burn** an object on, or damage the real or personal property connected to a building that is publicly or privately owned, leased, or used, including a cemetery, library, meeting hall, recreation center, or school:

- 25 (1) because a person or group of a particular race, color, religious belief, 26 sexual orientation, gender, disability, or national origin, or because a person or group that 27 is homeless, has contacts or is associated with the building; or
