## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages Licenses – Sunday Sales**

3 FOR the purpose of repealing the prohibition on certain license holders in Frederick County  
4 selling beer, beer and wine, or beer, wine, and liquor at a bar or counter on Sunday;  
5 and generally relating to alcoholic beverages sales on Sunday in Frederick County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 20–102.

20 This title applies only in Frederick County.

17                            [(2)    The license holder may not sell beer or wine at a bar or counter on  
18 Sunday.]

20            (d)    [(1)] A holder of a Class C beer, wine, and liquor license may sell beer, wine,  
21 and liquor for on– and off–premises consumption:

4 1, 2019.
