# 2 Public Health – Vaccination Reporting Requirements – ImmuNet

- FOR the purpose of requiring all health care providers in the State to report all vaccines
   administered to the Maryland immunization registry, ImmuNet; altering certain
   responsibilities of the Secretary of Health and the Maryland Department of Health
   relating to certain forms and a certain brochure; defining certain terms; making
   certain conforming changes; and generally relating to vaccination reporting
   requirements.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 (c) Subject to subsection (d) of this section, an authorized user may use the 13 information in ImmuNet for the following purposes:

14 (1) To provide coordinated immunization services, including sending 15 reminder notices to individuals who need immunizations;

16 (2) To obtain an individual immunization history;

17 (3) To identify geographic areas or population groups that are 18 underimmunized;

19 (4) To compile aggregate data and distribute statistical reports on the 20 status of immunizations in geographic areas and population groups;

- 21 (5) To assist in the management of State and local immunization programs;
- 22 (6) To monitor the safety of vaccines;

(7) To assess compliance with immunization requirements by monitoring
 admissions to schools, institutions of higher learning, and child care facilities; and

(8) For any other purpose that the Secretary deems necessary to preventthe spread of communicable diseases.

(d) (1) An individual, or the parent or guardian of a minor child who has
 received [an immunization] A VACCINATION, may refuse to permit disclosure of
 confidential information collected by ImmuNet, to an authorized user.

26 27 28 29	(i) An authorized user, including an officer or employee of a governmental unit, who knowingly and willfully violates subsection (f) of this section is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$1,000 for the first offense and not exceeding \$5,000 for each subsequent offense.

30 (j) If the confidentiality of records of Maryland citizens is protected, the Secretary 31 may enter into collaborative agreements with other states for the purpose of sharing

1 information about immunizations.

2 (k) The Secretary shall adopt regulations to implement this section, including 3 regulations specifying:

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2019.
