## A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Alcoholic Beverages – Sunday Sales at a Bar or Counter**

3 FOR the purpose of repealing the prohibition against holders of certain alcoholic beverages  
4 licenses in St. Mary's County from selling certain alcoholic beverages at a bar or  
5 counter on Sunday; and generally relating to the sale of alcoholic beverages in St.  
6 Mary's County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

21 This title applies only in St. Mary's County.

1 (a) A holder of a Class A beer and wine license may sell beer and wine on Monday  
2 through Sunday, from 6 a.m. to 2 a.m. the following day.

3 (b) [(1) Except as provided in paragraph (2) of this subsection, a] **A** holder of a  
4 Class B beer and wine license may sell beer and wine on Monday through Sunday, from 6  
5 a.m. to 2 a.m. the following day.

6 [(2) The license holder may not sell beer or wine at a bar or counter on  
7 Sunday.]

11 (a) A holder of a Class A beer, wine, and liquor license may sell beer, wine, and  
12 liquor on Monday through Sunday, from 6 a.m. to 2 a.m. the following day.

13 (b) [(1) Except as provided in paragraph (2) of this subsection, a] **A** holder of a  
14 Class B beer, wine, and liquor license may sell beer, wine, and liquor on Monday through  
15 Sunday, from 6 a.m. to 2 a.m. the following day.

16 [(2) The license holder may not sell beer, wine, or liquor at a bar or counter  
17 on Sunday.]

18 (c) [(1) Except as provided in paragraph (2) of this subsection, a] **A** holder of a  
19 Class C beer, wine, and liquor license may sell beer, wine, and liquor on Monday through  
20 Sunday, from 6 a.m. to 2 a.m. the following day.

21 [(2) The license holder may not sell beer, wine, or liquor at a bar or counter  
22 on Sunday.]

23 (d) A holder of a Class D beer, wine, and liquor license may sell beer, wine, and  
24 liquor on Monday through Sunday, from 6 a.m. to 2 a.m. the following day.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
26 1, 2019.
