A BILL ENTITLED

1 AN ACT concerning

2 Commission to Study Non-Emergency Medical Transportation Funding

3 FOR the purpose of establishing the Commission to Study Non-Emergency Medical 4 Transportation Funding; providing for the composition, cochairs, and staffing of the $\mathbf{5}$ Commission; prohibiting a member of the Commission from receiving certain 6 compensation, but authorizing the reimbursement of certain expenses; requiring the 7 Commission to study certain matters and make certain recommendations regarding 8 non-emergency medical transportation and locally operated transit systems; 9 requiring the Commission to consider certain matters when undertaking the study and making certain recommendations; requiring the Commission to report its 10 11 findings and recommendations to the Governor and certain committees of the 12General Assembly on or before a certain date; defining certain terms; providing for 13the termination of this Act; and generally relating to the Commission to Study 14Non-Emergency Medical Transportation Funding.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,16 That:

- 17 (a) (1) In this section the following words have the meanings indicated.
- 18 (2) "LOTS" means a locally operated transit system.
- 19 (3) "NEMT" means non–emergency medical transportation.
- 20 (b) There is a Commission to Study Non–Emergency Medical Transportation 21 Funding.
- 22 (c) The Commission consists of the following members:
- (1) two members of the Senate of Maryland, appointed by the President of
 the Senate;

(2)two members of the House of Delegates, appointed by the Speaker of 1 $\mathbf{2}$ the House: 3 (3)two individuals representing a dialysis provider network, one appointed 4 by the President of the Senate and one appointed by the Speaker of the House; $\mathbf{5}$ (4) the Comptroller of Maryland, or the Comptroller's designee; 6 (5)the Secretary of Health, or the Secretary's designee; 7 (6)the Secretary of Transportation, or the Secretary's designee; 8 the Executive Director of the Maryland Association of Counties, or the (7)Executive Director's designee; and 9 10 (8)the Executive Director of the Transportation Association of Maryland, 11 or the Executive Director's designee. 12(d)The President of the Senate and the Speaker of the House shall each designate a cochair of the Commission. 13 14 (e)The Maryland Department of Health and the Department of Transportation jointly shall provide staff for the Commission. 15A member of the Commission: 16 (f) 17(1)may not receive compensation as a member of the Commission; but 18 (2)is entitled to reimbursement for expenses under the Standard State 19Travel Regulations, as provided in the State budget. 20The Commission shall: (g) 21study Maryland's requirements for NEMT funding and the implications (1)22that the current demand for NEMT funding may have on other forms of transportation provided by LOTS; and 2324(2)make recommendations regarding the: 25criteria for choosing which medical providers would be required (i) to reimburse costs related to a patient's use of NEMT; and 2627(ii) best methodology for collecting and distributing NEMT 28reimbursements to LOTS providers. 29(h) In undertaking the study and making the recommendations required under
