1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Racetrack ~~License~~ and Racetrack**
3 **Concessionaire Licenses**

4 FOR the purpose of expanding the privileges of a racetrack license in Anne Arundel County;
5 specifying certain attributes of a licensed racing establishment; specifying the
6 location where beer, wine, and liquor may be sold under the license; specifying that
7 the playing of music and dancing may occur on the licensed premises; ~~authorizing~~
8 ~~the Board of License Commissioners to issue a concessionaire license;~~ allowing the
9 carrying and consuming of beer, wine, and liquor anywhere on the licensed premises;
10 altering the fee for a racetrack license; authorizing the Board of License
11 Commissioners to issue a racetrack concessionaire license to a certain person;
12 authorizing a holder of a racetrack concessionaire license to also hold a certain other
13 license; specifying the location where alcoholic beverages may be sold under the
14 racetrack concessionaire license; specifying that the playing of music and dancing
15 may occur on the licensed premises of the concessionaire; allowing alcoholic
16 beverages purchased under a racetrack concessionaire license to be taken into and
17 consumed on the licensed premises of the racing establishment; establishing the
18 annual license fee; specifying the days and hours of sale; stating that ~~the~~ a certain
19 license holder need not obtain a certain Sunday license; ~~authorizing a license holder~~
20 ~~to also hold a certain other license;~~ prohibiting a racetrack license or a racetrack
21 concessionaire license from being counted as a certain license for certain purposes;
22 making conforming changes; and generally relating to alcoholic beverages licenses
23 in Anne Arundel County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

20 This title applies only in Anne Arundel County.

17 COUNTY:

20 (2) § 2-209 (“CLASS 7 MICRO-BREWERY LICENSE”), SUBJECT TO §
21 ~~11-1007~~ § 11-1007.1 OF THIS TITLE; AND

22 (3) § 2-215 (“BEER SALE ON CREDIT TO RETAIL DEALER
23 PROHIBITED”), SUBJECT TO § 11-403 OF THIS SUBTITLE.

25 (a) There is a racetrack license.

26 (b) (1) The Board may issue the license to the owner of a [regularly] licensed
27 racing establishment THAT HOLDS ~~PUBLIC~~ RACE MEETINGS AT WHICH PARI-MUTUEL
28 BETTING IS ALLOWED.

1 (2) There are no residential or voting qualifications for a license applicant.

2 [(c) The license authorizes the license holder to sell alcoholic beverages at one or
3 more locations on the premises of the racing park.

4 (d) The license holder may sell alcoholic beverages from 2 hours before the
5 running of an authorized race to 2 hours after the running of an authorized race.]

6 (C) THE RACETRACK LICENSE AUTHORIZES:

7 (1) THE SALE OF BEER, WINE, AND LIQUOR IN A LOCATION OF THE
8 LICENSED RACING ESTABLISHMENT NOT COVERED BY A RACETRACK
9 CONCESSIONAIRE LICENSE THAT IS ISSUED IN ACCORDANCE WITH ~~SUBSECTION (D)~~
10 ~~OF THIS SECTION~~ § 11-1007.1 OF THIS SUBTITLE; AND

11 (2) THE PLAYING OF MUSIC AND DANCING ON THE LICENSED
12 PREMISES.

23 SUNDAY LICENSE TO SELL ALCOHOLIC BEVERAGES ON SUNDAY.

26 ~~(H) (F)~~ A RACETRACK LICENSE MAY NOT BE COUNTED AS A CLASS B
27 LICENSE OR A CLASS H LICENSE UNDER § 11-1609 OF THIS TITLE.

28 [(e)] ~~(H) (G)~~ The ANNUAL license fee is ~~\$60 per day of live or simulcast racing~~
29 \$25,000 to be paid to the Board on or before January 1 for the racing of the preceding year.

9 **CONCESSIONAIRE FOR CONSUMPTION ON:**

10 **1. THE LICENSED PREMISES OF THE CONCESSIONAIRE;**
11 **AND**

12 **2. THE LICENSED PREMISES OF THE RACING**
13 **ESTABLISHMENT;**

14 **(II) THE PLAYING OF MUSIC AND DANCING ON THE LICENSED**
15 **PREMISES OF THE CONCESSIONAIRE; AND**

16 **(III) IF THE LICENSE HOLDER IS ALSO THE HOLDER OF A CLASS**
17 **5 BREWERY LICENSE, THE SALE OF ONLY BEER IN ACCORDANCE WITH § 2-207 OF**
18 **THIS ARTICLE ON THE PREMISES OF THE CONCESSIONAIRE FOR CONSUMPTION ON:**

19 **1. THE LICENSED PREMISES OF THE CONCESSIONAIRE;**

22 **ESTABLISHMENT.**

23 **(2) ALCOHOLIC BEVERAGES PURCHASED UNDER THE LICENSE MAY**
24 **BE TAKEN INTO AND CONSUMED ON THE LICENSED PREMISES OF THE RACING**
25 **ESTABLISHMENT.**

26 **(D) (1) THE HOURS AND DAYS FOR THE SALE AND CONSUMPTION OF**
27 **ALCOHOLIC BEVERAGES UNDER THE LICENSE ARE THE SAME AS THE HOURS AND**
28 **DAYS SET OUT FOR A RACETRACK LICENSE UNDER § 11-1007 OF THIS SUBTITLE.**

1 **(2) A HOLDER OF THE LICENSE NEED NOT OBTAIN A SUNDAY LICENSE**
2 **UNDER § 11-2004 OF THIS TITLE TO SELL ALCOHOLIC BEVERAGES AFTER 2 A.M. ON**
3 **SUNDAY.**

4 **(E) THE LICENSE MAY NOT BE COUNTED AS A CLASS B OR CLASS H LICENSE**
5 **FOR PURPOSES OF § 11-1609 OF THIS TITLE.**

6 **(F) THE ANNUAL LICENSE FEE IS \$5,000.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2019.
