- FOR the purpose of establishing that inmates serving a term of life imprisonment may be paroled without the Governor's approval after serving a certain amount of time under certain circumstances; making stylistic changes; making a technical correction; and generally relating to sentences of life imprisonment.

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- (b) (1) Except as provided in paragraph (2) of this subsection, an inmate sentenced to life imprisonment is not eligible for parole consideration until the inmate has served 15 years or the equivalent of 15 years when considering allowances for diminution of the inmate's period of confinement as provided under Title 3, Subtitle 7 of this article

- 2 (ii) This paragraph does not restrict the authority of the Governor to 3 pardon or remit any part of a sentence under § 7–601 of this title.
- 4 (4) Subject to [paragraph] PARAGRAPHS (5) AND (6) of this subsection, if eligible for parole under this subsection, an inmate serving a term of life imprisonment may only be paroled with the approval of the Governor.
- 7 (5) (i) If the Commission decides to grant parole to an inmate sentenced 8 to life imprisonment who has served 25 years without application of diminution of 9 confinement credits, the decision shall be transmitted to the Governor.
- 10 (ii) The Governor may disapprove the decision by written 11 transmittal to the Commission.
- 12 (iii) If the Governor does not disapprove the decision within 180 days 13 after receipt, the decision becomes effective.
- 14 (6) If the Commission decides to grant parole to an inmate 15 sentenced to life imprisonment who has served 30 years without 16 application of diminution of confinement credits, the inmate shall be 17 paroled without the approval of the Governor.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2019.
