## A BILL ENTITLED

1 AN ACT concerning

2 **Queen Anne's County – Alcoholic Beverages – Beauty Salon and Barbershop**  
3 **License**

4 FOR the purpose of establishing a beauty salon and barbershop beer and wine license in  
5 Queen Anne's County; authorizing the Board of License Commissioners to issue the  
6 license to a holder of certain permits; specifying that the license authorizes the  
7 license holder to sell beer or wine by the glass for on-premises consumption to a  
8 customer while the customer is provided certain services; prohibiting the license  
9 from being transferred to another location; setting the hours of sale for the license;  
10 specifying that an establishment for which the license is issued is subject to certain  
11 alcohol awareness training requirements; setting an annual license fee; and  
12 generally relating to alcoholic beverages licenses in Queen Anne's County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That Section(s) 27–1001 of Article – Alcoholic Beverages of the Annotated Code of Maryland  
3 be renumbered to be Section(s) 27–1001.1.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
5 as follows:

6 **Article – Alcoholic Beverages**

7 27–102.

8 This title applies only in Queen Anne’s County.

9 **27–1001.**

10 (A) **THERE IS A BEAUTY SALON AND BARBERSHOP BEER AND WINE LICENSE.**

11 (B) **THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF:**

12 (1) **A BEAUTY SALON PERMIT ISSUED UNDER § 5–501 OF THE**  
13 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

14 (2) **A BARBERSHOP PERMIT ISSUED UNDER § 4–301 OF THE BUSINESS**  
15 **OCCUPATIONS AND PROFESSIONS ARTICLE.**

16 (C) **THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER OR**  
17 **WINE BY THE GLASS FOR ON–PREMISES CONSUMPTION TO A CUSTOMER WHILE THE**  
18 **CUSTOMER IS PROVIDED:**

19 (1) **A COSMETOLOGY SERVICE UNDER § 5–101(N) OF THE BUSINESS**  
20 **OCCUPATIONS AND PROFESSIONS ARTICLE OR AN ESTHETIC SERVICE UNDER §**  
21 **5–101(O) OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

22 (2) **A BARBERING SERVICE UNDER § 4–101(L) OF THE BUSINESS**  
23 **OCCUPATIONS AND PROFESSIONS ARTICLE.**

24 (D) **THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.**

25 (E) **THE LICENSE HOLDER MAY PROVIDE BEER AND WINE DURING NORMAL**  
26 **BUSINESS HOURS BUT NOT LATER THAN 9 P.M.**

1           **(F) AN ESTABLISHMENT FOR WHICH THE LICENSE IS ISSUED IS SUBJECT TO**  
2 **THE ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4-505 OF THIS**  
3 **ARTICLE.**

4           **(G) THE ANNUAL LICENSE FEE IS \$100.**

5           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
6 1, 2019.
