## Public Health - Cottage Food Products - Definition and Sale

- 3 FOR the purpose of altering the definition of "cottage food product" to include certain food sold in the State to retail food stores or food cooperatives; requiring that a certain 4 5 label for a cottage food product offered for sale at a retail food store include certain 6 information; requiring the owner of a cottage food business to submit certain 7 information to the Maryland Department of Health before selling a cottage food product to a retail food store; requiring the Department, on or before a certain date 8 9 each year, to submit a certain annual report to certain committees of the General 10 Assembly; and generally relating to cottage food products.

28 29 30	(2) On receipt of a complaint, a representative of the Department, at a reasonable time, may enter and inspect the premises of a cottage food business to determine compliance with this section.
