1 AN ACT concerning

Household Goods Movers Registration

3 FOR the purpose of prohibiting a person from providing household goods moving services 4 using a certain commercial motor vehicle in the State unless the person is registered 5 as a household goods mover under this Act; requiring a person to submit to the 6 Department of Labor, Licensing, and Regulation a certain application and a certain 7 fee to apply for a certain registration; establishing certain requirements and 8 procedures for the registration of household goods movers under this Act; requiring 9 the Department to issue a certain annual registration under certain circumstances; requiring a household goods mover to pay a certain fee each year and to retain a copy 10 of a certain registration in certain vehicles; requiring the Department to adopt 11 12 certain regulations; authorizing the Department to impose a certain penalty for 13 certain violations of this Act; defining certain terms; and generally relating to 14 household goods moving services and the registration of household goods movers.
