16 health care coverage or family health care coverage on projects that require a prevailing  
17 wage;

18 (2) for the year preceding the bid, what the percentage of total Social  
19 Security wages was, as well as the total amount spent on employee health care;

20 (3) what percentage of total health insurance coverage costs are paid by  
21 the insurance company, versus an employee, what the type and scope of the coverage are,  
22 and what the average percentage of the monthly premium paid by the bidder or  
23 subcontractor is; and

24 (4) what the average percentage of monthly premium paid by the bidder's  
25 employee or subcontractor's employee was, and the average per employee deductible for  
26 each health care plan offered.

27 (b) The Board of Public Works shall direct any relevant agency to include in any  
28 request for construction-related, competitive sealed bids the information required under  
29 subsection (a) of this section.

30 (c) On or before August 1, 2020, 2021, and 2022, the Board of Public Works shall  
31 report the information collected under this section for the previous fiscal year to the Senate  
32 Education, Health, and Environmental Affairs Committee and the House Health and



1 Government Operations Committee, in accordance with § 2-1246 of the State Government  
2 Article.
