2 ~~**Task Force on Forest Conservation in Maryland**~~

3 **Technical Study on Changes in Forest Cover and Tree Canopy in Maryland**

4 FOR the purpose of requiring the Harry R. Hughes Center for Agro-Ecology, in
5 consultation with the Department of Natural Resources, the Department of the
6 Environment, the Department of Planning, the Department of Agriculture, and the
7 Chesapeake Bay Program, to conduct a technical study to review changes in forest
8 cover and tree canopy in the State; providing for the scope of the technical study;
9 requiring the Harry R. Hughes Center for Agro-Ecology to submit a report of its
10 findings to the Governor and the General Assembly on or before a certain date;
11 providing for the termination of this Act; and generally relating to a technical study
12 to review changes in forest cover and tree canopy in Maryland. ~~establishing the Task~~
13 ~~Force on Forest Conservation in Maryland; providing for the composition, chair, and~~
14 ~~staffing of the Task Force; authorizing the Task Force to establish subcommittees;~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That:

~~(a) There is a Task Force on Forest Conservation in Maryland.~~

~~(b) The Task Force consists of the following members:~~

~~(1) the State Forester;~~

~~(2) one member of the Senate of Maryland, appointed by the President of the Senate;~~

~~(3) one member of the House of Delegates, appointed by the Speaker of the House;~~

~~(4) two representatives of county government, designated by the Maryland Association of Counties;~~

~~(5) two representatives of municipal government, designated by the Maryland Municipal League; and~~

~~(6) the following members, appointed jointly by the President of the Senate and the Speaker of the House:~~

~~(i) one representative of the Sustainable Forestry Council;~~

~~(ii) one representative of the Chesapeake Bay Program Office within the University of Maryland College of Agriculture and Natural Resources;~~

~~(iii) one representative of the Department of Agricultural and Resource Economics within the University of Maryland College of Agriculture and Natural Resources;~~

~~(iv) one representative of the Chesapeake Bay Commission;~~

~~(v) two representatives from environmental organizations;~~

~~(vi) one representative from a land preservation organization;~~

1 ~~(vii) two representatives from the commercial and residential~~
2 ~~development industries;~~

3 ~~(viii) one representative from an environmental restoration business~~
4 ~~involved in forest mitigation banking;~~

5 ~~(ix) one representative from a public utility; and~~

6 ~~(x) one representative from a public health organization.~~

7 ~~(e) The President of the Senate and the Speaker of the House shall jointly select~~
8 ~~the chair or cochairs of the Task Force.~~

9 ~~(d) The Harry R. Hughes Center for Agro-Ecology shall:~~

10 ~~(1) provide staff for the Task Force under contract with the Department of~~
11 ~~Natural Resources; and~~

12 ~~(2) facilitate the meetings of the Task Force and the preparation of its final~~
13 ~~report with assistance, as required by the Task Force, from the Department of Legislative~~
14 ~~Services, the Department of Natural Resources, the Department of the Environment, the~~
15 ~~Department of Planning, and the Department of Agriculture.~~

16 ~~(e) The Task Force may establish subcommittees as necessary to fulfill its duties.~~

17 ~~(f) A member of the Task Force:~~

18 ~~(1) may not receive compensation as a member of the Task Force; but~~

19 ~~(2) is entitled to reimbursement for expenses under the Standard State~~
20 ~~Travel Regulations, as provided in the State budget.~~

21 ~~(g) The Task Force shall:~~

22 ~~(1) undertake a technical review that includes, to the extent practicable:~~

23 (a) (1) The Harry R. Hughes Center for Agro-Ecology, in consultation with the
24 Department of Natural Resources, the Department of the Environment, the Department of
25 Planning, the Department of Agriculture, and the Chesapeake Bay Program, as
26 appropriate, shall conduct a technical study to review changes in forest cover and tree
27 canopy in the State.

28 (2) The technical study required under paragraph (1) of this subsection
29 shall, to the extent practicable, include:

30 (i) a survey and mapping of:

- 1 1. existing forest cover and tree canopy in the State; and
- 2 2. potential afforestation and reforestation locations in the
- 3 State;
- 4 (ii) an analysis of the health and quality of forests in the State;
- 5 (iii) an analysis of the progress toward the State's commitments to
- 6 expand urban tree canopy acres and plant riparian forest buffers under the 2014
- 7 Chesapeake Bay Agreement;
- 8 ~~(iii)~~ (iv) an analysis of observed and projected changes in land
- 9 cover and the amount of forest cover in the State due to development or other causes, using
- 10 the Chesapeake Bay Phase 6 Model, Chesapeake Assessment Scenario Tool (CAST), and
- 11 county and municipal forest conservation annual reports and land use plans, including the
- 12 extent and nature of:
- 13 1. mitigation activities involving existing forest conserved,
- 14 tree planting, reforestation, or afforestation under the Forest Conservation Act;
- 15 2. forest clearing, planting, and mitigation activity inside
- 16 and outside priority funding areas and locally designated growth areas; and
- 17 3. the clearing and mitigation of forest considered to be a
- 18 priority for retention and protection under § 5-1607(c) of the Natural Resources Article and
- 19 in State-identified targeted ecological areas and greenways, hubs, and corridors, and the
- 20 zoned density and sewer status of those areas; and
- 21 ~~(iv)~~ (v) an analysis of observed and projected changes in the
- 22 amount of forest cover in the State based on:
- 23 1. relevant State or local programs involving tree planting,
- 24 reforestation, or afforestation; and
- 25 2. the amount of forest preserved through federal, State, and
- 26 local programs, including agricultural preservation, open space, conservation easement,
- 27 and other land preservation programs;
- 28 (vi) a review of forest mitigation banking in the State, including:
- 29 1. capacity and location of active banks;
- 30 2. regulation of ~~existing~~ siting and creation of new banks;
- 31 3. geographic limitations on the use of mitigation banks;

1 4. the relationship between fee-in-lieu rates under the
2 Forest Conservation Act and the market for forest mitigation banks; and

3 5. whether expanding the use of forest mitigation banks
4 could provide water quality improvements and other beneficial results; and

5 (vii) a programmatic and funding review of federal,
6 State, and local tree and forest planting programs such as:

7 1. Marylanders Plant Trees;

8 2. Lawn to Woodland;

9 3. Backyard Buffers;

10 4. Conservation Reserve Enhance Program; and

11 5. other programs used to further TMDL Watershed
12 Implementation Plans and MS4 permit compliance.

13 (b) On or before December 1, 2019, the Harry R. Hughes Center for Agro-Ecology
14 shall submit a report of its findings of the technical study required under subsection (a) of
15 this section to the Governor and, in accordance with § 2-1246 of the State Government
16 Article, the General Assembly.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
18 1, 2019. It shall remain effective for a period of 1 year and 1 month and, at the end of June
19 30, 2020, this Act, with no further action required by the General Assembly, shall be
20 abrogated and of no further force and effect.
