17 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
 18 INDICATED.

19 (B) (1) “CREDIT CARD PROCESSOR” MEANS A PERSON THAT PROCESSES  
 20 CREDIT CARD OR ELECTRONIC COMMERCE TRANSACTIONS ON BEHALF OF A  
 21 BUSINESS ENTITY FOR A FEE.

22 (2) “CREDIT CARD PROCESSOR” INCLUDES:

23 (I) A MERCHANT SERVICES PROVIDER;

24 (II) A FINANCIAL INSTITUTION;

25 (III) AN INDEPENDENT SALES ORGANIZATION; AND

26 (IV) ANY SUBSIDIARY OR AFFILIATE OF AN ENTITY LISTED IN

11 **BUSINESS ENTITY AT THE TIME THE BUSINESS ENTITY SIGNS THE MERCHANT**
