BY repealing and reenacting, with amendments, Article – Natural Resources Section 4-11A-10(c)Annotated Code of Maryland (2018 Replacement Volume) BY adding to <u> Article – Natural Resources</u> Section 4–11A–10(c–1) Annotated Code of Maryland

7 3)	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect Jun 1, 2019. It shall remain effective for a period of 5 years and 1 month and, at the end of Jun 30, 2024, this Act, with no further action required by the General Assembly, shall b abrogated and of no further force and effect.
