# Higher Education – Policy on Student Concerns About Athletic Programs and Activities

4 FOR the purpose of requiring each institution of higher education to develop and adopt a  $\mathbf{5}$ certain policy that meets certain requirements on or before a certain date; 6 authorizing an institution of higher education to make changes to the policy under 7 certain circumstances; requiring each institution of higher education to post the 8 policy and any changes to the policy on the institution's website; requiring each 9 institution of higher education to ensure that each student who participates in the 10 institution's athletic programs or activities has a copy of the policy and any changes to the policy; requiring each institution of higher education to submit to the 11 12Maryland Higher Education Commission and certain committees of the General 13 Assembly the policy and any changes to the policy by a certain date; requiring each 14institution of higher education to submit to the Commission on or before a certain 15date each year the number of students who shared concerns under the policy; 16 requiring the Commission to report a summary of certain submissions to certain 17committees of the General Assembly on or before a certain date each year; providing 18 for the application of this Act; and generally relating to a policy on student concerns 19about athletic programs and activities.

7 (1) ON OR BEFORE OCTOBER 1, 2019, THE WRITTEN POLICY 8 ADOPTED IN ACCORDANCE WITH SUBSECTION (B)(1) OF THIS SECTION; AND

9 (2) ANY CHANGES TO THE POLICY.

10 (E) (1) ON OR BEFORE JULY 1, 2020, AND EACH JULY 1 THEREAFTER, 11 EACH INSTITUTION OF HIGHER EDUCATION SHALL REPORT TO THE COMMISSION ON 12 THE NUMBER OF STUDENTS WHO SHARED CONCERNS UNDER THE INSTITUTION'S 13 POLICY DURING THE IMMEDIATELY PRECEDING FISCAL YEAR.

14 (2) ON OR BEFORE AUGUST 1, 2020, AND EACH AUGUST 1 15 THEREAFTER, THE COMMISSION SHALL REPORT, IN ACCORDANCE WITH § 2–1246 OF 16 THE STATE GOVERNMENT ARTICLE, TO THE SENATE EDUCATION, HEALTH, AND 17 ENVIRONMENTAL AFFAIRS COMMITTEE AND THE HOUSE APPROPRIATIONS 18 COMMITTEE A SUMMARY OF THE SUBMISSIONS UNDER PARAGRAPH (1) OF THIS 19 SUBSECTION.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 21 1, 2019.
