A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Alcoholic Beverages – Class C Per Diem Licenses**

3 FOR the purpose of authorizing in St. Mary's County a Class C per diem license holder to
4 hold another license of a different class or nature; and generally relating to alcoholic
5 beverages licenses in St. Mary's County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

20 This title applies only in St. Mary's County.

- 1 (1) a Class C per diem beer license;
- 2 (2) a Class C per diem beer and wine license; and
- 3 (3) a Class C per diem beer, wine, and liquor license.
- 4 (b) The Board may:
- 5 (1) issue a license to a:
- 6 (i) religious, fraternal, civic, veterans', or charitable organization,
- 7 association, club, or society; or
- 8 (ii) hospital supporting organization; and
- 9 (2) impose conditions on the license.
- 10 (c) The period for which a license under this section may be issued is:
- 11 (1) for a Class C per diem beer license, not longer than 10 days;
- 12 (2) for a Class C per diem beer and wine license, 1 day; and
- 13 (3) for a Class C per diem beer, wine, and liquor license, 1 day.
- 14 (d) A license holder may purchase the alcoholic beverages to be sold under the
- 15 license from a retail dealer.
- 16 **(E) THE LICENSE HOLDER MAY HOLD ANOTHER LICENSE OF A DIFFERENT**
- 17 **CLASS OR NATURE.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July

19 1, 2019.
