3 FOR the purpose of altering the requirement that certain public schools be open for at least a certain number of days and a minimum number of hours during a certain period 4 $\mathbf{5}$ of time to require that the schools be open for at least a certain number of days or a 6 minimum number of hours during a certain period of time; providing that certain 7 funding for schools may not be reduced if there are fewer than a certain number of 8 school hours under certain circumstances; making conforming changes; and 9 generally relating to the required number of school days or school hours for elementary and secondary public schools. 10

11 (2) Nothing in this section precludes a county board from conducting a 12 year-round pilot study or program that is funded by the county board.

13 (f) Publicly funded prekindergarten programs are not subject to the 14 requirements of subsection (a) of this section.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2019.
