A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Sign Language Interpreter Act**

3 FOR the purpose of establishing the State Board of Sign Language Interpreters in the
4 Department of Labor, Licensing, and Regulation; providing that certain provisions
5 of law do not apply to certain individuals; providing for the composition of the Board
6 and the appointment, terms, qualifications, expenses, and removal of the Board
7 members; providing for the chair and the term of the chair of the Board; establishing
8 that a majority of members then serving is a quorum; requiring the Board to meet
9 quarterly a certain number of times each year; providing for the staff for the Board;
10 authorizing the Board to perform certain acts to enforce certain provisions of law;
11 providing for the powers and duties of the Board; requiring the Board to establish
12 criteria for the development of certain specialty area portfolios and certain
13 requirements for certain services; requiring the Board to maintain a certain list of
14 licensees and to make the list available to the public; authorizing the Board to set
15 certain fees for certain purposes; requiring certain fees to be paid to the Comptroller
16 and the Comptroller to distribute certain fees in a certain manner; establishing the
17 Sign Language Interpreters Fund; providing for the purpose of the Fund; requiring
18 the Director of the Office of the Deaf and Hard of Hearing to administer the Fund;
19 providing that the Fund is a special, nonlapsing fund, requiring the State Treasurer
20 to hold the Fund separately, and requiring the Comptroller to account for the Fund;
21 providing for the contents of the Fund; providing for certain uses of the Fund;
22 requiring the Treasurer to invest the money of the Fund in a certain manner and
23 requiring certain investment earnings to be credited to the General Fund of the
24 State; providing that certain expenditures must be made in accordance with the
25 State budget; requiring the Board to confirm the license status and qualifications of
26 an individual in a certain manner under certain circumstances; providing that the
27 Board exercises its powers, duties, and functions subject to the authority of the
28 Secretary of Labor, Licensing, and Regulation; requiring an individual, except under
29 certain circumstances, to be licensed by the Board before the individual may provide
30 sign language interpretation services in the State or make certain representations;
31 establishing certain qualifications for a supervisory license; authorizing the Board

1 to waive certain requirements for a certain license under certain circumstances;
2 requiring the Board to issue a certain license in a certain manner; providing that
3 certain licenses are not transferable; providing for the scope of certain licenses;
4 requiring a licensee to provide a certain notice to the Board to change certain
5 information on a license within a certain period of time; establishing a process for
6 the renewal of certain licenses; authorizing the Board to adopt certain regulations to
7 require a certain licensee to demonstrate continuing professional competency as a
8 condition of license renewal; providing for the reinstatement of certain licenses under
9 certain circumstances; providing for the issuance, term, and scope of a journeyworker
10 license; providing for the issuance, term, scope, and renewal of a provisional license;
11 authorizing the Board to impose certain sanctions on certain license holders or
12 applicants under certain circumstances; authorizing an individual sanctioned by the
13 Board to submit a certain request for review in a certain manner; authorizing the
14 Board to take certain actions on review; requiring the Board to commence certain
15 proceedings on receipt of a certain complaint; establishing certain hearing
16 procedures; authorizing the Board to reactivate a certain license under certain
17 circumstances; establishing that certain confidentiality and privileges apply to sign
18 language interpreters; establishing certain prohibited acts; authorizing certain
19 individuals to report certain violations of law to the Board within a certain period of
20 time; authorizing the Board to impose certain civil penalties for certain violations;
21 providing for certain criminal penalties; requiring the Board to provide a certain
22 written notice under certain circumstances; authorizing a certain person to bring a
23 certain action in court under certain circumstances; requiring that an evaluation of
24 the Board and the statutes and regulations that relate to the Board be performed on
25 or before a certain date; providing for a delayed effective date for certain licensing
26 requirements; requiring the Board to develop and implement a certain public
27 awareness campaign; providing that holding a certain certification satisfies a certain
28 licensing requirement for members initially appointed to the Board; requiring the
29 terms of certain initial members of the Board to expire in certain years; requiring
30 the Governor to include a certain General Fund appropriation in the budget bill for
31 a certain fiscal year for a certain purpose; defining certain terms; and generally
32 relating to the State Board of Sign Language Interpreters.

32 **(B) “AMERICAN SIGN LANGUAGE” MEANS A VISUAL–SPATIAL METHOD OF**
33 **COMMUNICATION THAT IS A DISTINCT LANGUAGE INVOLVING THE HANDS, ARMS,**
34 **FACIAL MARKERS, AND BODY MOVEMENTS TO COMMUNICATE WITH OTHERS,**

1 INCLUDING THROUGH THE CONVEYANCE OF THOUGHTS, WORDS, EMOTIONS, AND
2 GRAMMATICAL INFORMATION.

12 (E) "DIRECTOR" MEANS THE DIRECTOR OF THE OFFICE OF THE DEAF AND
13 HARD OF HEARING.

14 (F) "FUND" MEANS THE SIGN LANGUAGE INTERPRETERS FUND
15 ESTABLISHED UNDER § 22-207 OF THIS TITLE.

16 (G) "LEGAL SETTING" INCLUDES:

17 (1) COURT PROCEEDINGS;

18 (2) ATTORNEY-CLIENT CONFERENCES;

19 (3) INVESTIGATIONS BY LAW ENFORCEMENT;

20 (4) DEPOSITIONS;

21 (5) WITNESS INTERVIEWS;

22 (6) REAL ESTATE SETTLEMENTS; OR

23 (7) ADMINISTRATIVE HEARINGS.

24 (H) "LICENSE" MEANS A LICENSE ISSUED UNDER THIS TITLE TO PROVIDE
25 SIGN LANGUAGE INTERPRETATION SERVICES.

26 (I) "MEDICAL SETTING" INCLUDES:

1 **(1) AN ACUTE CARE HOSPITAL;**

2 **(2) AN URGENT CARE CENTER;**

3 **(3) AN OUTPATIENT CLINIC;**

4 **(4) SHORT-TERM CARE FACILITIES;**

5 **(5) LONG-TERM CARE FACILITIES;**

6 **(6) A PHYSICIAN'S OFFICE; AND**

7 **(7) HOME HEALTH CARE.**

8 **(J) "NATIONALLY RECOGNIZED CERTIFICATION" MEANS:**

9 **(1) A CERTIFICATION ISSUED BY:**

10 **(I) THE NATIONAL ASSOCIATION OF THE DEAF;**

11 **(II) THE REGISTRY OF INTERPRETERS FOR THE DEAF; OR**

12 **(III) THE CENTER FOR THE ASSESSMENT OF SIGN LANGUAGE**
13 **INTERPRETERS; OR**

14 **(2) ANY OTHER CERTIFICATION ISSUED BY A NATIONAL**
15 **ORGANIZATION THAT IS RECOGNIZED BY THE BOARD.**

19 **TO CONVEY THE MEANING OF A MESSAGE THAT IS EXPRESSED IN:**

20 **(I) AN ORAL LANGUAGE BY RENDERING THE MESSAGE IN**
21 **AMERICAN SIGN LANGUAGE; OR**

22 **(II) AMERICAN SIGN LANGUAGE BY RENDERING THE MESSAGE**
23 **IN AN ORAL LANGUAGE.**

24 **(2) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES"**
25 **INCLUDES PROVIDING SERVICES THROUGH VIDEO REMOTE INTERPRETING.**

1 (M) "SCHOOL SETTING" MEANS A SETTING IN WHICH THE FOLLOWING IS
2 PROVIDED:

3 (1) EDUCATIONAL PROGRAMS OR SERVICES OFFERED BY A PUBLIC
4 OR PRIVATE SCHOOL; OR

5 (2) CAREER TRAINING PROGRAMS FOR SECONDARY EDUCATION
6 STUDENTS THAT ARE REGULATED BY THE STATE DEPARTMENT OF EDUCATION.

7 (N) "SIGN LANGUAGE INTERPRETER" MEANS AN INDIVIDUAL WHO IS
8 LICENSED BY THE BOARD TO PROVIDE SIGN LANGUAGE INTERPRETATION
9 SERVICES.

10 (O) (1) "SUPERVISORY HOURS" MEANS THE HOURS DURING WHICH A
11 HOLDER OF A SUPERVISORY LICENSE SUPERVISES A HOLDER OF A PROVISIONAL
12 LICENSE TO PROVIDE OVERSIGHT OF THE ACCURACY OF THE SIGN LANGUAGE
13 INTERPRETATION SERVICE.

14 (2) "SUPERVISORY HOURS" DOES NOT INCLUDE THE HOURS SPENT IN
15 MENTORING, PROVIDING FEEDBACK, OR FORMAL OR INFORMAL INSTRUCTION.

16 (P) "VIDEO RELAY SERVICE" MEANS THE FEDERALLY REIMBURSED AND
17 REGULATED PROGRAM ESTABLISHED TO ENABLE PHONE CALLS BETWEEN USERS OF
18 AMERICAN SIGN LANGUAGE AND INDIVIDUALS WHO DO NOT USE AMERICAN SIGN
19 LANGUAGE VIA VIDEOCONFERENCING TECHNOLOGY AND USING THE SERVICES OF
20 A REMOTELY LOCATED SIGN LANGUAGE INTERPRETER.

21 (Q) (1) "VIDEO REMOTE INTERPRETING SETTING" MEANS PROVIDING
22 SIGN LANGUAGE INTERPRETATION SERVICE VIA VIDEOCONFERENCING IN WHICH AT
23 LEAST ONE INDIVIDUAL IS AT A SEPARATE LOCATION.

24 (2) "VIDEO REMOTE INTERPRETING SETTING" DOES NOT INCLUDE
25 VIDEO RELAY SERVICE.

6 **(I) A BEHAVIORAL HEALTH SETTING, UNLESS THE INDIVIDUAL**
7 **IS ACCOMPANIED BY A LICENSED SIGN LANGUAGE INTERPRETER;**

8 **(II) A MEDICAL SETTING, UNLESS THE INDIVIDUAL IS**
9 **ACCOMPANIED BY A LICENSED SIGN LANGUAGE INTERPRETER;**

10 **(III) A LEGAL SETTING;**

11 **(IV) A SCHOOL SETTING;**

12 **(V) A VIDEO RELAY INTERPRETING SETTING; OR**

13 **(VI) A VIDEO RELAY SERVICE SETTING;**

14 **(2) (I) 1. DOES NOT PROVIDE SIGN LANGUAGE INTERPRETING**
15 **SERVICES IN THE STATE FOR MORE THAN 80 HOURS EACH CALENDAR YEAR; OR**

16 **2. SELF-CERTIFIES ELIGIBILITY FOR THE EXEMPTION;**
17 **AND**

18 **(II) NOTIFIES THE BOARD OF EACH INTERPRETING**
19 **ASSIGNMENT THE INDIVIDUAL COMPLETES WITHIN 10 DAYS AFTER PROVIDING SIGN**
20 **LANGUAGE INTERPRETING SERVICES;**

21 **(3) ENGAGES IN SIGN LANGUAGE INTERPRETING AS AN**
22 **UNCOMPENSATED VOLUNTEER AND IN A SETTING IN WHICH A SIGN LANGUAGE**

27 **(5) INTERPRETS BETWEEN A PAIR OF SIGNED LANGUAGES FOR**

6 **(A) (1) THE BOARD CONSISTS OF NINE MEMBERS.**

7 **(2) THE MEMBERS SHALL BE APPOINTED BY THE GOVERNOR WITH**
8 **THE ADVICE OF THE DIRECTOR AS FOLLOWS:**

9 **(I) ONE SHALL BE A MEMBER OF THE MARYLAND ADVISORY**
10 **COUNCIL FOR THE DEAF AND HARD OF HEARING;**

11 **(II) ONE SHALL BE A MEMBER OF THE MARYLAND ASSOCIATION**
12 **OF THE DEAF;**

18 **(V) TWO SHALL BE DEAF INDIVIDUALS WHO HOLD A LICENSE**
19 **UNDER SUBTITLE 3 OF THIS TITLE;**

20 **(VI) TWO SHALL BE HEARING INDIVIDUALS WHO HOLD A**
21 **LICENSE UNDER SUBTITLE 3 OF THIS TITLE; AND**

22 **(VII) ONE SHALL BE A REPRESENTATIVE FROM AN INTERPRETER**
23 **PREPARATION PROGRAM BASED IN THE STATE.**

24 **(3) THE GOVERNOR SHALL APPOINT THE MEMBERS, WITH THE**
25 **ADVICE OF THE DIRECTOR, FROM A LIST OF NAMES SUBMITTED TO THE GOVERNOR**
26 **FROM A NOMINATION PROCESS ESTABLISHED BY THE OFFICE.**

1 **(B) EACH MEMBER OF THE BOARD MUST:**

2 **(1) BE A RESIDENT OF THE STATE; AND**

3 **(2) BE PROFICIENT IN AMERICAN SIGN LANGUAGE.**

4 **(C) (1) THE TERM OF A MEMBER IS 3 YEARS, BEGINNING ON THE DATE OF**
5 **APPOINTMENT.**

6 **(2) THE TERMS OF THE MEMBERS ARE STAGGERED AS REQUIRED BY**
7 **THE TERMS PROVIDED FOR MEMBERS OF THE BOARD ON OCTOBER 1, 2019.**

8 **(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL**
9 **A SUCCESSOR IS APPOINTED AND QUALIFIES.**

10 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
11 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
12 **QUALIFIES.**

13 **(5) A MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE FULL**
14 **TERMS.**

15 **(D) BEFORE TAKING OFFICE, EACH APPOINTEE TO THE BOARD SHALL TAKE**
16 **THE OATH REQUIRED BY ARTICLE I, § 9 OF THE MARYLAND CONSTITUTION.**

17 **(E) (1) THE GOVERNOR MAY REMOVE A MEMBER FOR INCOMPETENCE,**
18 **MISCONDUCT, NEGLIGENCE OF DUTIES, OR OTHER SUFFICIENT CAUSE.**

19 **(2) THE GOVERNOR SHALL REMOVE A MEMBER WHO:**

20 **(I) CEASES TO MEET THE REQUIREMENTS UNDER WHICH THE**
21 **MEMBER WAS APPOINTED, AS PROVIDED UNDER SUBSECTIONS (A) AND (B) OF THIS**
22 **SECTION; OR**

23 **(II) FAILS TO ATTEND AT LEAST 50% OF THE REGULARLY**

16 **TO MANAGE THE OPERATIONS OF THE BOARD.**

17 **(2) THE STAFF SHALL BE RESPONSIBLE FOR ASSISTING THE BOARD**
18 **IN CARRYING OUT ITS RESPONSIBILITIES UNDER THIS TITLE, INCLUDING:**

19 **(I) PROVIDING INFORMATION TO THE PUBLIC ABOUT SIGN**
