## Agriculture – Hemp Research and Production

FOR the purpose of altering the name of the Industrial Hemp Pilot Program to be the Hemp Research Pilot Program; establishing the Hemp Farming Program; establishing the purposes of the Hemp Farming Program; requiring the Department of Agriculture to administer the Hemp Farming Program; establishing the Hemp Farming Fund as a special, nonlapsing fund; specifying the purpose of the Fund; requiring the Department to administer the Fund; requiring the State Treasurer to hold the Fund and the Comptroller to account for the Fund; specifying the contents of the Fund; specifying the purpose for which the Fund may be used; providing for the investment of money in and expenditures from the Fund; requiring interest earnings of the Fund to be credited to the Fund; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the State; requiring the Department, in consultation with the Governor and the Attorney General, to establish a certain plan for monitoring and regulating the production of hemp in the State; requiring the Department to submit a certain plan to the Secretary of the U.S. Department of Agriculture; requiring the Department to establish a procedure for licensing the production of hemp in accordance with a certain plan; authorizing the Department to set certain fees; requiring the Department to pay certain fees into the Fund; prohibiting a person from producing hemp in the State unless the person is licensed by the Department or the Secretary of the U.S. Department of Agriculture; requiring the Department to report certain violations to the Attorney General and the U.S. Attorney; requiring the Department to require a person to correct certain violations in a certain manner under certain
