## A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Forfeiture of Firearms – Sale to Dealer**

3 FOR the purpose of authorizing, in Allegany County, Carroll County, Frederick County,  
4 Garrett County, and Washington County, a certain law enforcement unit to sell,  
5 exchange, or transfer certain forfeited firearms to a certain firearms dealer under  
6 certain circumstances; and generally relating to forfeiture of firearms.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Criminal Procedure**

15 13–206.

16 (a) [Whenever] **EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION,**  
17 **WHENEVER** property is forfeited under this subtitle, the law enforcement unit that sought  
18 forfeiture of the property may only:

19 (1) order the property retained for the official use of the law enforcement  
20 unit;

21 (2) destroy the forfeited property; or

22 (3) sell, exchange, or transfer the forfeited property to another law

2 (b) (1) THIS SUBSECTION APPLIES ONLY IN:

3 (I) ALLEGANY COUNTY;

4 (II) CARROLL COUNTY;

5 (III) FREDERICK COUNTY;

6 (IV) GARRETT COUNTY; AND

7 (V) WASHINGTON COUNTY.

8 (2) WHENEVER A FIREARM IS FORFEITED UNDER THIS SUBTITLE,  
9 THE LAW ENFORCEMENT UNIT THAT SOUGHT FORFEITURE OF THE FIREARM MAY  
10 SELL, EXCHANGE, OR TRANSFER THE FORFEITED FIREARM TO A FEDERALLY  
11 LICENSED FIREARMS DEALER.

12 (C) Within 30 days after disposing of forfeited property, a law enforcement unit  
13 shall send to the Secretary of State Police:

14 (1) a description of the property forfeited;

15 (2) the type of disposition made; and

16 (3) the identity of the person to whom the property was transferred for  
17 disposal, retention, or official use.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
19 October 1, 2019.
