1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Filing Period for Renewal Applications**

3 FOR the purpose of altering the time period within which an applicant is required to submit
4 an application to renew an alcoholic beverages license in Harford County; and
5 generally relating to alcoholic beverages in Harford County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 22–102.

3 (a) The following sections of Title 4, Subtitle 4 (“Renewal of Local Licenses”) of
4 Division I of this article apply in the county without exception or variation:

5 (1) § 4-402 (“Eligibility for renewal; process”);

6 (2) § 4-403 (“Renewal application”);

7 (3) § 4-406 (“Protests”);

8 (4) § 4-407 (“Denial of renewal application”);

9 (5) § 4-408 (“Issuance of renewed licenses”);

10 (6) § 4-409 (“Multiple licenses”); and

11 (7) § 4-410 (“Chain store, supermarket, or discount house”).

12 **(B) SECTION 4-404 (“FILING PERIOD FOR RENEWAL APPLICATION”) OF**
13 **DIVISION I OF THIS ARTICLE DOES NOT APPLY IN THE COUNTY AND IS SUPERSEDED**
14 **BY § 22-1802 OF THIS SUBTITLE.**

15 **[(b)] (C)** [The following sections of Title 4, Subtitle 4 (“Renewal of Local
16 Licenses”) of Division I of this article apply in the county:

17 (1) § 4-404 (“Filing period for renewal application”), subject to § 22-1802
18 of this subtitle; and

19 (2) **§] SECTION 4-405 (“Contents of renewal application”) OF DIVISION I**
20 **OF THIS ARTICLE APPLIES IN THE COUNTY**, subject to § 22-1803 of this subtitle.

22 **(A) AN APPLICATION TO RENEW AN ANNUAL LICENSE SHALL BE FILED**
23 **BETWEEN FEBRUARY 1 AND APRIL 1, INCLUSIVE.**

24 **(B)** The Board may consider a license renewal application received after April 1
25 for 30 days before it takes final action on the application.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2019.
