A BILL ENTITLED

1 AN ACT concerning

2 **Commercial Law – Consumer Protection – Ticket Website Domain**

3 FOR the purpose of authorizing a certain person operating on behalf of a venue or an
4 entertainment event to use the word “official” in a certain lower–level domain name;
5 requiring certain ticket resellers to use the word “reseller” in the lower–level domain
6 name in the URL of a ticket website; and generally relating to ticket sales website
7 domain names.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Commercial Law**

16 14–4003.

17 [(a) This section does not apply to a person who is acting on behalf of a venue.]

18 **(A) A PERSON WHO OWNS, OPERATES, OR CONTROLS A TICKET WEBSITE**
19 **AND IS ACTING ON BEHALF OF A VENUE OR AN ENTERTAINMENT EVENT MAY USE IN**
20 **THE URL OF THE TICKET WEBSITE A LOWER–LEVEL DOMAIN NAME THAT CONTAINS**
21 **THE WORD “OFFICIAL”.**

22 (b) A person who owns, operates, or controls a ticket website [may] **AND IS NOT**
23 **ACTING ON BEHALF OF A VENUE OR AN ENTERTAINMENT EVENT:**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(1) SHALL USE THE WORD “RESELLER” IN THE LOWER-LEVEL**
2 **DOMAIN NAME OF THE URL OF THE TICKET WEBSITE; AND**

3 **(2) MAY** not use in the URL of the ticket website a lower-level domain
4 name that contains:

5 **[(1) (I)]** The name of the venue for which the ticket grants admission;

6 **[(2) (II)]** The name of the entertainment event, including the name of an
7 individual or a group scheduled to perform or appear at the event; or

8 **[(3) (III)]** A name substantially similar to the name in item **[(1) (I)]** or **[(2)**
9 **(II)]** of this [subsection] **ITEM.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2019.
