CHAPTER _____

1 AN ACT concerning

2 **Maryland Health Benefit Exchange – Functions and Outreach**

3 FOR the purpose of requiring the Maryland Health Benefit Exchange to conduct outreach
4 and education activities for certain purposes; requiring the Exchange to perform
5 certain functions for Maryland Medical Assistance programs, as requested by the
6 Maryland Department of Health and approved by the Board of Trustees for the
7 Exchange, for a certain purpose; defining a certain term; and generally relating to
8 the functions and operations of the Maryland Health Benefit Exchange.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That Section(s) 31–101(h) through (aa), respectively, of Article – Insurance of the
7 Annotated Code of Maryland be renumbered to be Section(s) 31–101(i) through (bb),
8 respectively.

9 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
10 as follows:

11 **Article – Insurance**

12 31–101.

13 **(H) “HEALTH LITERACY” MEANS THE DEGREE TO WHICH AN INDIVIDUAL**
14 **HAS THE CAPACITY TO OBTAIN, PROCESS, AND UNDERSTAND HEALTH INFORMATION**
15 **AND SERVICES IN ORDER TO MAKE AN APPROPRIATE HEALTH DECISION.**

17 (b) [On or before January 1, 2014, in] IN compliance with § 1311(d)(4) of the
18 Affordable Care Act, the Exchange shall:

19 (1) make qualified plans available to qualified individuals and qualified
20 employers;

21 (2) allow a carrier to offer a qualified dental plan through the Exchange
22 that provides limited scope dental benefits that meet the requirements of § 9832(c)(2)(A) of
23 the Internal Revenue Code, either separately, in conjunction with, or as an endorsement to
24 a qualified health plan, provided that the qualified health plan provides pediatric dental
25 benefits that meet the requirements of § 1302(b)(1)(J) of the Affordable Care Act;

26 (3) allow a carrier to offer a qualified vision plan through the Exchange
27 that provides limited scope vision benefits that meet the requirements of § 9832(c)(2)(A) of
28 the Internal Revenue Code, either separately, in conjunction with, or as an endorsement to
29 a qualified health plan, provided that the qualified health plan provides pediatric vision
30 benefits that meet the requirements of § 1302(b)(1)(J) of the Affordable Care Act;

31 (4) consistent with the guidelines developed by the Secretary under §
32 1311(c) of the Affordable Care Act, implement procedures for the certification,
33 recertification, and decertification of:

34 (i) health benefit plans as qualified health plans;

1 (ii) dental plans as qualified dental plans; and

2 (iii) vision plans as qualified vision plans;

3 (5) provide for the operation of a toll-free telephone hotline to respond to
4 requests for assistance;

5 (6) provide for initial, annual, and special enrollment periods, in
6 accordance with guidelines adopted by the Secretary under § 1311(c)(6) of the Affordable
7 Care Act;

8 (7) maintain a Web site through which enrollees and prospective enrollees
9 of qualified plans may obtain standardized comparative information on qualified health
10 plans, qualified dental plans, and qualified vision plans;

11 (8) with respect to each qualified plan offered through the Exchange:

12 (i) assign a rating to each qualified plan in accordance with the
13 criteria developed by the Secretary under § 1311(c)(3) of the Affordable Care Act and any
14 additional criteria that may be applicable under the laws of the State and regulations
15 adopted by the Exchange under this title; and

16 (ii) determine each qualified health plan's coverage level in
17 accordance with regulations adopted by the Secretary under § 1302(d)(2)(A) of the
18 Affordable Care Act and any additional regulations adopted by the Exchange under this
19 title;

20 (9) (i) present qualified plan options offered by the Exchange in a
21 standardized format, including the use of the uniform outline of coverage established under
22 § 2715 of the federal Public Health Service Act; and

23 (ii) to the extent necessary, modify the standardized format to
24 accommodate differences in qualified health plan, qualified dental plan, and qualified
25 vision plan options;

26 (10) in accordance with § 1413 of the Affordable Care Act, provide
27 information and make determinations regarding eligibility for the following programs:

28 (i) the Maryland Medical Assistance Program under Title XIX of the
29 Social Security Act;

30 (ii) the Maryland Children's Health Program under Title XXI of the
31 Social Security Act; and

32 (iii) any applicable State or local public health insurance program;

33 (11) facilitate the enrollment of any individual who the Exchange

1 determines is eligible for a program described in item (10) of this subsection;

2 (12) establish and make available by electronic means a calculator to
3 determine the actual cost of coverage of a qualified plan offered by the Exchange after
4 application of any premium tax credit under § 36B of the Internal Revenue Code and any
5 cost-sharing reduction under § 1402 of the Affordable Care Act;

6 (13) in accordance with this title, establish a SHOP Exchange through
7 which qualified employers may access coverage for their employees at specified coverage
8 levels and meet standards for the federal qualified employer tax credit;

9 (14) implement a certification process for individuals exempt from the
10 individual responsibility requirement and penalty under § 5000A of the Internal Revenue
11 Code on the grounds that:

12 (i) no affordable qualified health plan that covers the individual is
13 available through the Exchange or the individual's employer; or

14 (ii) the individual meets other requirements under the Affordable
15 Care Act that make the individual eligible for the exemption;

16 (15) implement a process for transfer to the United States Secretary of the
17 Treasury the name and taxpayer identification number of each individual who:

18 (i) is certified as exempt from the individual responsibility
19 requirement;

20 (ii) is employed but determined eligible for the premium tax credit
21 on the grounds that:

22 1. the individual's employer does not provide minimum
23 essential coverage; or

24 2. the employer's coverage is determined to be unaffordable
25 for the individual or does not provide the requisite minimum actuarial value;

26 (iii) notifies the Exchange under § 1411(b)(4) of the Affordable Care
27 Act that the individual has changed employers; or

28 (iv) ceases coverage under a qualified health plan during the plan
29 year, together with the date coverage ceased;

30 (16) provide notice to employers of employees who cease coverage under a
31 qualified health plan during a plan year, together with the date coverage ceased;

32 (17) conduct processes required by the Secretary and the United States
33 Secretary of the Treasury to determine eligibility for premium tax credits, reduced

1 cost-sharing, and individual responsibility requirement exemptions;

2 (18) establish a Navigator Program in accordance with § 1311(i) of the
3 Affordable Care Act and this title;

4 (19) carry out a plan to provide appropriate assistance for consumers
5 seeking to purchase products through the Exchange, including the implementation of:

6 (i) a navigator program for the SHOP Exchange and a navigator
7 program for the Individual Exchange; and

8 (ii) the toll-free hotline required under item (5) of this subsection;
9 [and]

10 (20) carry out a public relations and advertising campaign to promote the
11 Exchange;

12 **(21) CONDUCT OUTREACH AND EDUCATION ACTIVITIES TO INCREASE**
13 **HEALTH LITERACY AND TO EDUCATE CONSUMERS ABOUT THE EXCHANGE AND**
14 **INSURANCE AFFORDABILITY PROGRAMS THAT:**

15 **(I) INCLUDE MINORITY POPULATIONS;**

16 **(II) DO NOT INCLUDE CLINICAL OR INDIVIDUAL HEALTH**
17 **INFORMATION RELATED TO A SPECIFIC HEALTH CONDITION; AND**

18 **(III) INCREASE PARTICIPATION IN THE EXCHANGE; AND**

19 **(22) PERFORM ADMINISTRATIVE, TECHNOLOGICAL, OPERATIONAL,**
20 **AND REPORTING FUNCTIONS FOR MARYLAND MEDICAL ASSISTANCE PROGRAMS, AS**
21 **REQUESTED BY THE MARYLAND DEPARTMENT OF HEALTH AND APPROVED BY THE**
22 **BOARD, TO THE EXTENT THAT THE PERFORMANCE OF THE FUNCTIONS AID IN THE**
23 **EFFICIENT OPERATIONS OF THE EXCHANGE AND THE MARYLAND MEDICAL**
24 **ASSISTANCE PROGRAMS.**

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
26 1, 2019.
