14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

18 19 20	(a) (1) Subject to subsections (b) and (c) of this section, the Commissioner shall require an insurance producer to receive continuing education as a condition of renewing the license of the insurance producer.

3 4	[(2)] (3) (i) The Commissioner may not require an individual who holds a license to receive more than 24 hours of continuing education per renewal period.
5 6 7	(ii) If the individual holds a title insurance producer license, the Commissioner may not require the insurance producer to receive more than 16 hours of continuing education per renewal period.
8 9 10	(iii) If an insurance producer has held a license for 25 or more consecutive years as of October 1, 2008, the Commissioner may not require the insurance producer to receive more than 8 hours of continuing education per renewal period.

[(4)] **(5)** (i) To increase the level of education of insurance producers, an insurance producer shall obtain continuing education in the kind or subdivision of 32 33 insurance for which the insurance producer has received a license.

- 1 (ii) Each insurance producer who possesses a license to sell health 2 insurance and who sells long-term care insurance shall receive continuing education that 3 directly relates to long-term care insurance.
- 4 (iii) Each insurance producer who possesses a license to sell property 5 and casualty insurance and who sells flood insurance shall receive continuing education 6 that directly relates to flood insurance.
- 7 (iv) Each insurance producer who possesses a license to sell property 8 and casualty insurance and who sells, solicits, or negotiates bail bonds shall receive 9 continuing education that directly relates to bail bond insurance.
- 10 (v) Each insurance producer who possesses a license to sell health 11 insurance and who markets the Senior Prescription Drug Assistance Program or assists a 12 Medicare beneficiary to enroll in the Senior Prescription Drug Assistance Program shall 13 receive continuing education that directly relates to the Senior Prescription Drug 14 Assistance Program.
- [(5)] (6) If continuing education is required, the Commissioner may grant a waiver to an insurance producer who has requested a waiver for reasons that the Commissioner determines warrant the waiver.
- 18 **[(6)] (7)** An insurer may not prohibit one of its insurance producers from obtaining continuing education credits from any course approved by the Commissioner.
- 20 (b) The following individuals are exempt from the continuing education 21 requirements under this section:
- 22 (1) employees of a health maintenance organization who are employed 23 solely to solicit membership in the health maintenance organization under a contract 24 between the health maintenance organization and the Maryland Department of Health;
- 25 (2) attorneys at law of the State who are qualified as title insurance 26 producers and who do not hold a license in any other kind or subdivision of insurance;
- 27 (3) individuals who hold only a limited lines license to act as an insurance 28 producer for limited line credit insurance; and
- 29 (4) insurance producers who hold only a limited lines license in any type of 30 insurance designated by the Commissioner.
- 31 (c) A nonresident licensee shall be deemed to have met the continuing education 32 requirements of this section if:
- 33 (1) the nonresident licensee satisfies the continuing education 34 requirements of the home state of the nonresident licensee; and

- 1 (2) the home state of the nonresident licensee allows an insurance producer 2 who is a resident of this State to satisfy the continuing education requirements of the home 3 state on the same basis by meeting the continuing education requirements of this State.
- 4 (d) (1) The Commissioner may review all continuing education courses submitted and approve or disapprove courses.
- 6 (2) The Commissioner may not disapprove a continuing education course 7 solely on the basis of the methodology or technology used to deliver instruction to 8 individuals taking the course.
- 9 (d-1) (1) An insurance producer may obtain all or part of the credit hours of 10 continuing education required for renewal of a license under this section from 11 correspondence courses or online courses approved by the Commissioner.
- 12 (2) This subsection applies to all insurance producers who are required to 13 receive continuing education as a condition of license renewal under this section, regardless 14 of the kind or subdivision of insurance for which the insurance producer has received a 15 license.
- 16 (e) The Commissioner may adopt regulations to carry out this section.

- 21 (a) A license expires every other year on the date stated on the license unless 22 renewed as provided in this section.
- 23 (b) At least 1 month before a license expires, the Commissioner shall send to the 24 holder of the license, at the last known address or e-mail address of the holder on record a 25 notice that states:

- 27 (2) the date by which the Commissioner must receive the renewal 28 application for the renewal to be issued and mailed before the license expires; and

13 14 15 16	(2) A PUBLIC ADJUSTER SHALL COMPLETE THE CONTINUING EDUCATION REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION NOT LATER THAN 30 DAYS BEFORE THE EXPIRATION DATE OF THE PUBLIC ADJUSTER'S LICENSE.
17 18 19	[(2)] (3) The public adjuster shall successfully complete 24 credit hours of approved continuing education for each 2-year license period as a condition for license renewal unless the Commissioner modifies the requirement by regulation.
20 21 22	[(3)] (4) Of the required hours of continuing education required for a renewal period under paragraph [(2)] (3) of this subsection, at least 3 hours shall relate directly to ethics.
23 24	[(4)] (5) The Commissioner may grant a waiver to a public adjuster who has requested a waiver for reasons that the Commissioner determines warrant the waiver.
25 26	[(5)] (6) This subsection may not apply to a holder of a license who has not been licensed for 1 full year before the end of the applicable continuing education period.

- 4 (g) (1) If mailed, an application for renewal of a license shall be considered 5 made in a timely manner if it is postmarked on or before the expiration date of the license.
- 6 (2) If submitted electronically, an application for renewal shall be considered made in a timely manner if, on or before the expiration date of the license, the application:
- 9 (i) is addressed properly or otherwise directed properly to an information processing system that the Administration has designated or uses for the purpose of receiving electronic applications and from which the Administration is able to retrieve the application;
- 13 (ii) is in a form capable of being processed by that system; and
- 14 (iii) 1. enters an information processing system outside the control of the sender or of a person that sent the electronic application on behalf of the sender; or
- 2. enters a region of the information processing system designated or used by the Administration that is under the control of the Administration or an agent of the Administration.
- 20 (h) (1) The Commissioner shall renew the license of each holder who meets the 21 requirements of this section.
- 22 (2) If the holder of a license files an application for renewal before the 23 license expires, the license shall remain in effect until:
- 24 (i) the Commissioner issues a renewal license; or
- 25 (ii) 5 days after the Commissioner refuses in writing to renew the 26 license and serves notice of the refusal on the holder.
