1 AN ACT concerning

2 **Baltimore City – Police Department – Reports on Funds**

3 FOR the purpose of requiring the Baltimore Police Department to submit a certain annual
4 report on certain funds received from the Governor’s Office of Crime Control and
5 Prevention; and generally relating to funds for the Baltimore Police Department.

6 BY adding to

7 Article – Public Safety

8 Section 4–1201 to be under the new subtitle “Subtitle 12. Baltimore Police
9 Department Funds”

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 **SUBTITLE 12. BALTIMORE POLICE DEPARTMENT FUNDS.**

16 **4–1201.**

1 **(A) THIS SUBTITLE APPLIES ONLY TO EACH GRANT THE EXECUTIVE**
2 **DIRECTOR OF THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION**
3 **MAKES TO THE BALTIMORE POLICE DEPARTMENT.**

4 **(B) THE PURPOSE OF THIS SUBTITLE IS TO ENSURE THAT GRANTS FROM**
5 **THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION TO THE**
6 **BALTIMORE POLICE DEPARTMENT FOR COMMUNITY POLICING EFFORTS ARE USED**
7 **FOR THAT PURPOSE.**

8 **(C) (1) IN FISCAL YEAR 2019, THE BALTIMORE POLICE DEPARTMENT**
9 **SHALL PREPARE A HALF-YEAR REPORT ON THE EXPENDITURE OF GRANTS**
10 **RECEIVED FROM THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION.**

11 **(2) IN FISCAL YEAR 2020 AND IN EACH SUBSEQUENT FISCAL YEAR,**
12 **THE BALTIMORE POLICE DEPARTMENT SHALL PREPARE AN ANNUAL REPORT ON**
13 **THE EXPENDITURE OF GRANTS RECEIVED FROM THE GOVERNOR'S OFFICE OF**
14 **CRIME CONTROL AND PREVENTION.**

15 **(D) THE REPORT REQUIRED UNDER SUBSECTION (C) OF THIS SECTION**
16 **SHALL INCLUDE:**

17 **(1) THE INTENDED USE OF EACH GRANT FROM THE GOVERNOR'S**
18 **OFFICE OF CRIME CONTROL AND PREVENTION TO THE BALTIMORE POLICE**
19 **DEPARTMENT; AND**

20 **(2) THE SPECIFIC EXPENDITURES MADE BY THE BALTIMORE POLICE**
21 **DEPARTMENT WITH ANY MONETARY GRANTS RECEIVED FROM THE GOVERNOR'S**
22 **OFFICE OF CRIME CONTROL AND PREVENTION.**

23 **(E) ON OR BEFORE DECEMBER 31 EACH YEAR, THE BALTIMORE POLICE**
24 **DEPARTMENT SHALL SUBMIT THE REPORT REQUIRED UNDER SUBSECTION (C) OF**
25 **THIS SECTION TO THE BALTIMORE CITY DELEGATION TO THE GENERAL ASSEMBLY,**
26 **IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 October 1, 2019.
