## A BILL ENTITLED

1 AN ACT concerning

### 2 **Farm Area Motor Vehicles – Registration and Authorized Use**

3 FOR the purpose of repealing the termination date for certain provisions of law applicable  
4 to the registration and authorized use of farm area motor vehicles, including a  
5 provision increasing the radius from a farm within which a person may operate on a  
6 highway a motor vehicle registered as a farm area motor vehicle; making this Act an  
7 emergency measure; and generally relating to the registration and authorized use of  
8 farm area motor vehicles.

9 BY repealing and reenacting, without amendments,

16 Section 2

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

### 19 **Article – Transportation**

20 13–935.

21 (a) (1) In this section the following words have the meanings indicated.

22 (2) “Farm area motor vehicle” means a motor vehicle owned by a farmer

1 and operated only on a farm or on a highway within a 25-mile radius of the farm.

2 (f) In applying for registration of a farm area motor vehicle under this section,  
3 the owner of the vehicle shall submit with the application, from the most recent federal tax  
4 filing of the owner, a copy of:

5 (1) Internal Revenue Service form 1040, schedule F; or

6 (2) Any other federal tax form showing active farming status, as  
7 determined by the Administration.

8 **Chapter 146 of the Acts of 2014**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
10 measure, is necessary for the immediate preservation of the public health or safety, has  
11 been passed by a yea and nay vote supported by three-fifths of all the members elected to  
12 each of the two Houses of the General Assembly, and shall take effect from the date it is  
13 enacted. [It shall remain effective for a period of 5 years from the date it is enacted and, at  
14 the end of the 5-year period, with no further action required by the General Assembly, this  
15 Act shall be abrogated and of no further force and effect.]

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
17 measure, is necessary for the immediate preservation of the public health or safety, has  
18 been passed by a yea and nay vote supported by three-fifths of all the members elected to  
19 each of the two Houses of the General Assembly, and shall take effect from the date it is  
20 enacted.
