- 2 (a) In this article, unless the context requires otherwise, the following words have 3 the meanings indicated.
- 4 (f) "Department" means the State Department of Education.
- 5 9.5–111.
- 6 (a) (1) In this section the following words have the meanings indicated.
- 7 (2) "Analysis" means the market rate survey or an alternative method 8 allowable under federal law.
- 9 (3) "Program" means the Child Care Subsidy Program.
- 10 (d) The Governor shall include in the annual State budget an appropriation from 11 all fund sources for the Program that is not less than the total appropriation for the 12 Program in fiscal year 2018 or fiscal year 2019, whichever is greater.
- 13 (e) The Governor shall, from all fund sources, appropriate funds in the annual 14 State budget in an amount sufficient to raise the Program's reimbursement rates for each 15 region to:
- 16 (1) For fiscal year 2020, not less than the 30th percentile of the most recent 17 market rate survey or its equivalent if an alternative methodology defined by the 18 Department is used; AND
- 19 (2) For fiscal year 2021 **AND EACH FISCAL YEAR THEREAFTER**, not less 20 than the **[**45th**] 60TH** percentile of the most recent market rate survey or its equivalent if 21 an alternative methodology defined by the Department is used **[**; and
- 22 (3) For fiscal year 2022 and each fiscal year thereafter, not less than the 23 60th percentile of the most recent market rate survey or its equivalent if an alternative 24 methodology defined by the Department is used].
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 26 1, 2019.
