A BILL ENTITLED

1 AN ACT concerning

2 **Judgeships – Circuit Court and District Court**

3 FOR the purpose of altering the number of resident judges of the circuit court in a certain
4 county; altering the number of resident judges of the District Court in certain
5 districts; and generally relating to judgeships in circuit courts and the District Court.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Courts and Judicial Proceedings**

14 1–503.

15 (a) In each county in the first seven judicial circuits there shall be the number of
16 resident judges of the circuit court set forth below, including the judge or judges provided
17 for by the Constitution:

18	(1) Allegany.....	2
19	(2) Anne Arundel	13
20	(3) Baltimore County.....	20
21	(4) Calvert.....	3
