3 FOR the purpose of ~~authorizing the chairman or vice chairman of the State Board of~~  
4 ~~Elections to seek an injunction against a violation of the campaign finance laws;~~  
5 ~~repealing the authority of the Secretary of State to seek an injunction against a~~  
6 ~~violation of the campaign finance laws;~~ authorizing a candidate to seek an injunction  
7 against certain violations of the campaign finance laws against a certain person  
8 campaign finance entity; and generally relating to injunctive relief against violations

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Election Law**

18 13–605.

19 (a) The ~~[Secretary of State]~~ ~~CHAIRMAN OR THE VICE CHAIRMAN OF THE~~  
20 ~~STATE BOARD~~ may seek an immediate injunction against any violation of this title.

11 [(b)] (C) A person who violates an injunction issued under this section:

12 (1) is in criminal contempt; and

13 (2) is guilty of a misdemeanor and on conviction is subject to a fine not  
14 exceeding \$250 or imprisonment not exceeding 30 days or both.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 October 1, 2019.
