1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Promoter’s Permit**

3 FOR the purpose of repealing in Frederick County a certain requirement for a promoter’s
4 permit, so that an event that a for–profit organization seeks to publicize, sell tickets
5 for, organize, produce, or stage need not be conducted in conjunction with a nonprofit
6 organization that holds a certain license; altering certain permit fees; and generally
7 relating to promoter’s permits in Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

2 This title applies only in Frederick County.

4 (a) There is a promoter's permit.

5 (b) A for-profit organization shall obtain the permit from the Board before the
6 organization may [help] publicize, sell tickets for, organize, operate, produce, or stage an
7 event[:

8 (1)] at which alcoholic beverages are sold or served[; and

9 (2) that is conducted in conjunction with an organization that holds a
10 license issued under Subtitle 13, Part III of this title].

11 (c) The Board may adopt regulations establishing the requirements for
12 conducting an event described in subsection (b) of this section, including health and safety
13 standards to be met by a permit holder.

14 (d) The permit fee is:

15 **(1) \$50, IF THE PROMOTER EXPECTS THAT FEWER THAN 500**
16 **INDIVIDUALS WILL ATTEND;**

17 ~~(2)~~ **(2)** \$250, if the promoter expects that ~~fewer than~~ **FROM 500 TO** 1,000
18 individuals will attend;

19 ~~(3)~~ **(3)** \$600, if the promoter expects that from 1,001 to 3,000 individuals
20 will attend; and

21 ~~(4)~~ **(4)** \$1,000, if the promoter expects that more than 3,000 individuals
22 will attend.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2019.
