A BILL ENTITLED

1 AN ACT concerning

2 **Real Property – Homeowners Associations – Number of Declarant Votes**

3 FOR the purpose of altering the number of declarant votes before the date on which all lots
4 that may be part of a development have been subdivided and recorded under certain
5 circumstances; providing that a declarant is entitled to a certain number of votes
6 beginning on the date on which all lots that may be part of a development have been
7 subdivided and recorded under certain circumstances; and generally relating to
8 declarant votes in homeowners associations.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Real Property**

17 11B–111.7.

18 **(A)** Notwithstanding any other provision of law or any provision in the
19 declaration, bylaws, rules, deeds, agreements, or recorded covenants or restrictions of a
20 homeowners association, [until the time all lots in a homeowners association] **BEGINNING**
21 **ON THE DATE ON WHICH ALL LOTS THAT MAY BE PART OF THE DEVELOPMENT** have
22 been subdivided and recorded in the land records of the county in which the homeowners
23 association is located, the declarant, when voting on a homeowners association matter,
24 shall [have a number of votes that is equal to the number of lots that] **BE ENTITLED TO**
25 **ONE VOTE PER LOT THAT:**

1 (1) [Have] **HAS** been subdivided and recorded in the land records of the
2 county in which the homeowners association is located; and

3 (2) [Have] **HAS** not been sold to members of the public.

4 **(B) BEFORE THE DATE ON WHICH ALL LOTS THAT MAY BE PART OF THE**
5 **DEVELOPMENT HAVE BEEN SUBDIVIDED AND RECORDED IN THE LAND RECORDS OF**
6 **THE COUNTY IN WHICH THE HOMEOWNERS ASSOCIATION IS LOCATED, THE**
7 **DECLARANT, WHEN VOTING ON A HOMEOWNERS ASSOCIATION MATTER, SHALL BE**
8 **ENTITLED TO THE NUMBER OF VOTES SET FORTH IN THE GOVERNING DOCUMENTS**
9 **OF THE HOMEOWNERS ASSOCIATION.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2019.
