## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Baltimore–Washington International Thurgood Marshall Airport – Security**  
3 **Screening Checkpoint – Charitable Donations**

4 FOR the purpose of requiring the Executive Director of the Maryland Aviation  
5 Administration to place donation boxes at the entrance to each security screening  
6 checkpoint at the Baltimore–Washington International Thurgood Marshall Airport;  
7 requiring that money deposited in the donation boxes be appropriated ~~for the benefit~~  
8 ~~of a certain program and be used to supplement, but not supplant, certain other~~  
9 ~~funds; defining certain terms~~ to the Department of Disabilities to be used only for  
10 certain programs for individuals with disabilities; defining a certain term; and  
11 generally relating to donation boxes and the Baltimore–Washington International  
12 Thurgood Marshall Airport.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

8 (B) THE EXECUTIVE DIRECTOR SHALL PLACE AND MAINTAIN DONATION  
9 BOXES AT THE ENTRANCE TO EACH SECURITY SCREENING CHECKPOINT AT THE  
10 BALTIMORE-WASHINGTON INTERNATIONAL THURGOOD MARSHALL AIRPORT.

11 (C) THE MONEY DEPOSITED IN THE DONATION BOXES REQUIRED UNDER  
12 SUBSECTION (B) OF THIS SECTION SHALL BE:

13 ~~(1)~~ ~~APPROPRIATED FOR THE BENEFIT OF THE PROGRAM; AND~~

14 ~~(2)~~ ~~USED TO SUPPLEMENT, BUT NOT SUPPLANT, ANY OTHER~~  
15 ~~FUNDING AVAILABLE FOR THE PROGRAM~~ APPROPRIATED FOR THE DEPARTMENT  
16 OF DISABILITIES TO BE USED ONLY TO SUPPORT TRANSITIONAL HOUSING  
17 PROGRAMS FOR INDIVIDUALS WITH DISABILITIES.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
19 October 1, 2019.
