Environment – Water Quality Certifications (Pipeline and Water Protection Act of 2019)

4 FOR the purpose of requiring a person seeking to construct a natural gas pipeline to apply $\mathbf{5}$ for a certain water quality certification and pay a certain fee; requiring the 6 Department of the Environment to establish a certain fee for the submission and 7 review of a water quality certification application; specifying how the Department 8 will determine the amount of the fee; requiring that the fee be deposited, credited, 9 and appropriated in a certain manner; requiring the Department to review a water 10 quality certification application in accordance with certain provisions of law; 11 prohibiting the Department from waiving certain authority to review a water quality 12certification application; requiring the Department to review a water quality 13 certification application for completeness within a certain number of days; requiring 14the Department to provide a certain notice under certain circumstances; specifying 15the criteria that must be included in the Department's review of a water quality 16certification application; authorizing the Department to request certain information 17in a certain manner during its review of a water quality certification application; 18 authorizing the Department to deny a water quality certification application under 19certain circumstances; requiring the Department to take certain actions if the 20Department determines that a water quality certification application should be 21 approved; requiring the Department to take a certain action on a water quality 22certification application within a certain period of time; requiring a person seeking 23to construct a natural gas pipeline to submit certain plans to the Department; 24prohibiting a person from beginning to construct a certain natural gas pipeline until 25a certain approval authority approves certain plans; requiring the approval 26authority to review and make a certain decision on certain plans and revisions of 27certain plans within a certain number of days; requiring the approval authority to 28provide a certain rationale to a certain person in a certain manner; defining certain 29terms; making this Act an emergency measure; and generally relating to water 30 quality certifications.

AND BE IT FURTHER ENACTED, That this Act is an emergency 2 measure, is necessary for the immediate preservation of the public health or safety, has 3 been passed by a yea and nay vote supported by three-fifths of all the members elected to 4 each of the two Houses of the General Assembly, and shall take effect from the date it is 5 enacted.
