1 (a) A person may not operate any vessel on the Severn River from April 15, 1989
2 to October 15, 1989 in excess of 40 miles per hour during the following days and times:

3 (1) A Saturday;

4 (2) A Sunday;

5 (3) A State holiday; and

6 (4) Any other day from sundown to sunrise.

8 (b) (1) Except as provided in subsection (d) of this section, a person may not
9 operate a vessel on the waters of the State so as to exceed a noise level of 90dB(a).

10 (3) An owner or lessee of a vessel may not allow the vessel to be operated
11 on waters of the State in violation of paragraph (1) of this subsection.

13 (a) A person may not operate a vessel on Seneca Creek in Montgomery County at
14 a speed in excess of 6 knots.

16 (a) A person may not operate a vessel on the Monocacy River between Starner's
17 Dam and the upstream island in Carroll and Frederick counties at a speed in excess of 6
18 knots.

20 (a) A person may not throw, dump, deposit, or cause to be thrown, dumped, or
21 deposited any trash, junk, or other refuse on any waters of the State.

22 8-726.1.

23 (b) Ballast, ashes, filth, earth, oysters, or oyster shells may not be deposited from
24 a vessel to a site:

25 (1) In the Chesapeake Bay above Sandy Point;

26 (2) In Herring Bay; or

27 (3) Below the high water mark in a river, creek, or harbor in the State.

2 (b) Except as provided in subsection (c) of this section, an individual who is on a
3 vessel may not display or operate a flashing, alternating red and yellow light or signal
4 device.

6 (a) A person may not:

7 (1) Operate a vessel recklessly or in a manner that may endanger another
8 or the property of another on a bay, creek, lake, river, or stream in the State; or

9 (2) Come into a wharf or bathing shore recklessly or in a manner that may
10 endanger a person or property.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2019.
