Pedestrian Safety Fund Act of 2019

3 FOR the purpose of establishing the minimum fine that may be imposed for a violation of 4 certain provisions of the Maryland Vehicle Law regarding crosswalks; establishing $\mathbf{5}$ the Pedestrian Safety Fund as a special, nonlapsing fund; requiring the Secretary of 6 Transportation to administer the Fund; requiring the State Treasurer to hold the 7 Fund separately, and the Comptroller to account for the Fund; specifying the 8 contents of the Fund; specifying the purpose for which the Fund may be used; 9 providing for the investment of money in the Fund; requiring interest earnings of 10 the Fund to be credited to the Fund; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the 11 12State; defining a certain term; and generally relating to the Pedestrian Safety Fund.

5 (1) DEVELOPING AND PROVIDING EDUCATIONAL PROGRAMMING FOR 6 BICYCLISTS, MOTORISTS, AND PEDESTRIANS THAT RAISES AWARENESS OF THEIR 7 JOINT RESPONSIBILITY TO FOLLOW THE RULES OF THE ROAD;

8 (2) PHYSICAL DESIGN CHANGES THAT CALM TRAFFIC, MINIMIZE 9 CONFLICTS AMONG STREET USERS, AND PROTECT BICYCLISTS, MOTORISTS, AND 10 PEDESTRIANS, INCLUDING DESIGN CHANGES SUCH AS:

- 15 (V) SPEED BUMPS;
- 16 (VI) CURB EXTENSIONS; AND
- 17 (VII) SAFETY ZONES; AND

18 (3) INCREASING ENFORCEMENT OF EXISTING RULES OF THE ROAD,
19 SUCH AS BY USING RADAR SPEED DISPLAY SIGNS IN AREAS WHERE PEDESTRIAN

21 (G) (1) THE TREASURER SHALL INVEST THE MONEY OF THE FUND IN THE 22 SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

23(2)ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED24TO THE FUND.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 2019.
