### 1 AN ACT concerning

# Property Tax – In Rem Foreclosure <u>and Sale</u> and <u>Sale</u> – Vacant and Abandoned Property

FOR the purpose of requiring a tax collector to withhold from tax sale certain real property 4  $\mathbf{5}$ designated by a county or municipal corporation for *foreclosure and* sale under a 6 certain process; authorizing a county or municipal corporation to initiate an in rem 7 foreclosure and sale of certain real property for delinguent taxes; requiring 8 authorizing a county or municipal corporation to enact certain laws authorizing in 9 rem foreclosure and sale of certain real property; <del>requiring</del> authorizing the county 10 or municipal corporation to commence an in rem foreclosure action; prohibiting the county or municipal corporation from commencing an in rem foreclosure action until 11 12tax on real property has been delinguent for a certain period and the right to appeal 13a certain notice has tolled; requiring the county or municipal corporation to send 14 certain notice to certain taxing agencies before filing a certain complaint: requiring

16(A)WITHIN 90 DAYS AFTER EACH SALE, THE COUNTY OR MUNICIPAL17CORPORATION SHALL FILE A REPORT OF THE SALE WITH THE CIRCUIT COURT.

18 **(B)** THE REPORT SHALL IDENTIFY THE SALE THAT TOOK PLACE, THE SALE 19 PRICE, AND THE IDENTIFY OF THE PURCHASER.

20 (C) THE COUNTY OR MUNICIPAL CORPORATION MAY CONSOLIDATE 21 MULTIPLE SALE REPORTS.

22 SECTION 2. AND BE IT FURTHER ENACTED, That the Court of Appeals shall 23 adopt rules to carry out the provisions of this Act.

24 SECTION 3. AND BE IT FURTHER ENACTED, That a county or municipality may 25 not file a complaint for an in rem foreclosure action in accordance with this Act until the 26 rules adopted by the Court of Appeals under Section 2 of this Act are effective.

# SECTION 4. 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2019.
