7 (ii) encourage small businesses to engage in federal research and
8 development that has the potential for commercialization;

9 (iii) facilitate the transfer of technology from small businesses; and

10 (iv) encourage small businesses to apply for federal small business
11 innovation research grants and small business technology transfer grants;

12 (2) study the laws and regulations of other states governing financial
13 assistance programs for awardees of federal small business innovation research grants and
14 small business technology transfer grants; and

15 (3) make recommendations regarding financing options for recipients of
16 federal small business innovation research grants and small business technology transfer
17 grants.

18 (b) On or before December 31, 2019, the Department of Commerce shall submit its
19 findings and recommendations to the General Assembly, in accordance with § 2-1246 of the
20 State Government Article.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2019. It shall remain effective for a period of 1 year and, at the end of June 30, 2020, this
23 Act, with no further action required by the General Assembly, shall be abrogated and of no
24 further force and effect.
