CHAPTER _____

1 AN ACT concerning

2 **Criminal Law – Human Trafficking and Prostitution Offenses**

3 FOR the purpose of altering the elements of the prohibitions against human trafficking and
4 renaming them sex trafficking; prohibiting a person from violating certain provisions
5 of this Act with the use of or intent to use force, threat, coercion, or fraud; prohibiting
6 a person from knowingly receiving a certain benefit in relation to a violation of
7 certain provisions of this Act; prohibiting a person from knowingly engaging in
8 certain conduct with the intent to compel another to marry any person under certain
9 circumstances; prohibiting a person from destroying, concealing, removing,
10 confiscating, or possessing certain documents while violating certain provisions of
11 this Act; prohibiting a person from aiding, abetting, or conspiring with another to
12 violate certain provisions of this Act; establishing that the lack of knowledge about
13 a victim's age is not a defense to certain offenses involving a child; establishing
14 certain penalties for violations of this Act; reorganizing certain provisions of law
15 relating to prostitution; defining certain terms; altering certain definitions; making
16 conforming changes; and generally relating to human trafficking and prostitution
17 offenses.

3 (a) (1) A person may not knowingly:

4 (i) take or cause another to be taken to any place for prostitution;

5 (ii) place, cause to be placed, or harbor another in any place for
6 prostitution;

7 (iii) persuade, induce, entice, or encourage another to be taken to or
8 placed in any place for prostitution;

9 (iv) receive consideration to procure for or place in a house of
10 prostitution or elsewhere another with the intent of causing the other to engage in
11 prostitution or assignation;

12 (v) engage in a device, scheme, or continuing course of conduct
13 intended to cause another to believe that if the other did not take part in a sexually explicit
14 performance, the other or a third person would suffer physical restraint or serious physical
15 harm; or

16 (vi) destroy, conceal, remove, confiscate, or possess an actual or
17 purported passport, immigration document, or government identification document of
18 another while otherwise violating or attempting to violate this subsection.

19 (2) A parent, guardian, or person who has permanent or temporary care or
20 custody or responsibility for supervision of another may not consent to the taking or
21 detention of the other for prostitution.

22 (b) (1) A person may not violate subsection (a) of this section involving a victim
23 who is a minor.

24 (2) A person may not [knowingly take or detain another] **VIOLATE**
25 **SUBSECTION (A) OF THIS SECTION** with the **USE OF OR** intent to use force, threat,
26 coercion, or fraud [to compel the other to marry the person or a third person or perform a
27 sexual act, sexual contact, or vaginal intercourse].

28 (c) (1) (i) Except as provided in paragraph (2) of this subsection, a person
29 who violates subsection (a) of this section is guilty of the misdemeanor of [human
30 trafficking] **SEX TRAFFICKING** and on conviction is subject to imprisonment not exceeding
31 10 years or a fine not exceeding \$5,000 or both.

32 (ii) A person who violates subsection (a) of this section is subject to §
33 5-106(b) of the Courts Article.

1 (2) A person who violates subsection (b) of this section is guilty of the felony
2 of [human trafficking] **SEX TRAFFICKING** and on conviction is subject to imprisonment not
3 exceeding 25 years or a fine not exceeding \$15,000 or both.

4 (d) A person who violates this section may be charged, tried, and sentenced in any
5 county in or through which the person transported or attempted to transport the other.

6 (e) (1) A person who knowingly benefits financially [or] by receiving anything
7 of value from participation in a venture that includes an act described in subsection (a) or
8 (b) of this section is subject to the same penalties that would apply if the person had violated
9 that subsection.

10 (2) A person who knowingly aids, abets, or conspires with one or more other
11 persons to violate any subsection of this section is subject to the same penalties that apply
12 for a violation of that subsection.

13 (f) It is not a defense to a prosecution under subsection (b)(1) **OR (E)** of this
14 section that the person did not know the age of the victim.

16 **(A) A PERSON MAY NOT KNOWINGLY:**

17 **(1) TAKE OR DETAIN ANOTHER WITH THE INTENT TO USE FORCE,**
18 **THREAT, COERCION, OR FRAUD TO COMPEL THE OTHER TO MARRY ANY PERSON;**

19 **(2) RECEIVE A FINANCIAL BENEFIT OR THING OF VALUE IN RELATION**
20 **TO A VIOLATION OF THIS SUBSECTION; OR**

21 **(3) AID, ABET, OR CONSPIRE WITH ANOTHER TO VIOLATE THIS**
22 **SUBSECTION.**

23 **(B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF THE FELONY OF**
24 **FORCED MARRIAGE AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT**
25 **EXCEEDING 25 YEARS OR A FINE NOT EXCEEDING \$15,000 OR BOTH.**

26 **(C) A PERSON WHO VIOLATES THIS SECTION MAY BE CHARGED, TRIED, AND**
27 **SENTENCED IN ANY COUNTY IN OR THROUGH WHICH THE PERSON TRANSPORTED OR**
28 **ATTEMPTED TO TRANSPORT THE VICTIM.**

13 (d) “Sexual act” has the meaning stated in § 3-301 of this article.

14 (e) “Sexual contact” has the meaning stated in § 3-301 of this article.

15 (f) “Sexually explicit performance” means a public or private, live, photographed,
16 recorded, or videotaped act or show in which the performer is wholly or partially nude, and
17 which is intended to sexually arouse or appeal to the prurient interest of patrons or viewers.

19 commanding another.

22 (a) A person may not knowingly:

23 (1) engage in prostitution or assignment by any means; **OR**

24 (2) [keep, set up,] occupy[, maintain, or operate] a building, structure, or
25 conveyance for prostitution or assignment[;

26 (3) allow a building, structure, or conveyance owned or under the person’s
27 control to be used for prostitution or assignment;

28 (4) allow or agree to allow a person into a building, structure, or conveyance
29 for prostitution or assignment; or

30 (5) procure or solicit or offer to procure or solicit for prostitution or

1 assignation].

2 (b) A person who violates this section is guilty of a misdemeanor and on conviction
3 is subject to imprisonment not exceeding 1 year or a fine not exceeding \$500 or both.

4 (c) (1) Subject to paragraph (2) of this subsection, in a prosecution under this
5 section, it is an affirmative defense of duress if the defendant committed the act as a result
6 of being a victim of an act of another [who was charged with violating the prohibition
7 against human trafficking under § 11–303 of this subtitle or] **IN VIOLATION OF TITLE 3,
8 SUBTITLE 11 OF THIS ARTICLE OR THE PROHIBITION AGAINST HUMAN TRAFFICKING**
9 under federal law.

10 (2) A defendant may not assert the affirmative defense provided in
11 paragraph (1) of this subsection unless the defendant notifies the State's Attorney of the
12 defendant's intention to assert the defense at least 10 days prior to trial.

14 (a) For the purpose of committing a crime under Title 3, Subtitle 3 of this article,
15 a person may not:

16 (1) persuade or entice or aid in the persuasion or enticement of an
17 individual under the age of 16 years from the individual's home or from the custody of the
18 individual's parent or guardian; and

19 (2) knowingly secrete or harbor or aid in the secreting or harboring of the

9 (A) A PERSON MAY NOT KNOWINGLY:

10 (1) ALLOW A BUILDING, STRUCTURE, OR CONVEYANCE OWNED OR
11 UNDER THE PERSON'S CONTROL TO BE USED FOR PROSTITUTION OR ASSIGNATION;

12 (2) ALLOW OR AGREE TO ALLOW A PERSON INTO A BUILDING,
13 STRUCTURE, OR CONVEYANCE FOR PROSTITUTION OR ASSIGNATION; OR

14 (3) KEEP, SET UP, MAINTAIN, OR OPERATE A BUILDING, STRUCTURE,
15 OR CONVEYANCE FOR PROSTITUTION OR ASSIGNATION.

16 (B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR
17 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A
18 FINE NOT EXCEEDING \$500 OR BOTH.

19 (C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IN A
20 PROSECUTION UNDER THIS SECTION, IT IS AN AFFIRMATIVE DEFENSE OF DURESS IF
21 THE DEFENDANT COMMITTED THE ACT AS A RESULT OF BEING A VICTIM OF AN ACT
22 OF ANOTHER IN VIOLATION OF TITLE 3, SUBTITLE 11 OF THIS ARTICLE OR THE
23 PROHIBITION AGAINST HUMAN TRAFFICKING UNDER FEDERAL LAW.

29 (a) In this section, "crime of violence" means:

30 (24) assault with intent to commit a sexual offense in the first degree; [and]

31 (25) assault with intent to commit a sexual offense in the second degree;

2 (26) FELONY SEX TRAFFICKING UNDER § 3-1102(B) OF THIS ARTICLE.

5 (a) A person convicted of prostitution under [§ 11-306] § 11-303 of the Criminal
6 Law Article may file a motion to vacate the judgment if, when the person committed the
7 act or acts of prostitution, the person was acting under duress caused by an act of another
8 committed in violation of [the prohibition against human trafficking under
9 § 11-303] TITLE 3, SUBTITLE 11 of the Criminal Law Article or THE PROHIBITION
10 AGAINST HUMAN TRAFFICKING under federal law.

11 10-110.

12 (a) A person may file a petition listing relevant facts for expungement of a police
13 record, court record, or other record maintained by the State or a political subdivision of
14 the State if the person is convicted of:

15 (1) a misdemeanor that is a violation of:

16 (xiv) [§ 11-306(a)] § 11-303, § 11-306, OR § 11-307 of the Criminal
17 Law Article;

19 (f) “Shieldable conviction” means a conviction of one of the following crimes:

2 The following are subject to forfeiture:

3 (1) except as provided in § 13-503 of this subtitle, a motor vehicle used in
4 connection with a violation of and conviction under [§ 11-303] § 3-1102 OR § 3-1103 of
5 the Criminal Law Article;

6 (2) money used in connection with a violation of and conviction under the
7 human trafficking law, found in close proximity to or at the scene of the arrest for a violation
8 of the human trafficking law; and

13 (a) Property or an interest in property described in § 13-502(1) or (3) of this
14 subtitle may not be forfeited if the owner establishes by a preponderance of the evidence
15 that the violation of the human trafficking law was committed without the owner's actual
16 knowledge.

17 (b) (1) A motor vehicle for hire in the transaction of business as a common
18 carrier or a motor vehicle for hire may not be seized or forfeited under this subtitle unless
19 it appears that the owner or other person in charge of the motor vehicle was a consenting
20 party or privy to a violation of the human trafficking law.

21 (2) A motor vehicle may not be forfeited under this subtitle for an act or
22 omission that the owner shows was committed or omitted by a person other than the owner
23 while the person other than the owner possessed the motor vehicle in criminal violation of
24 federal law or the law of any state.

25 (c) Subject to subsection (d) of this section, real property used as the principal
26 family residence may not be forfeited under this subtitle unless one of the owners of the
27 real property was convicted of a violation of [§ 11-303] § 3-1102 OR § 3-1103 of the
28 Criminal Law Article or of an attempt or conspiracy to violate [§ 11-303] § 3-1102 OR §
29 3-1103 of the Criminal Law Article.

30 (d) Real property used as the principal family residence by a husband and wife
31 and held by the husband and wife as tenants by the entirety may not be forfeited unless:

32 (1) the property was used in connection with a violation of [§ 11-303]
33 § 3-1102 OR § 3-1103 of the Criminal Law Article or with an attempt or a conspiracy to
34 violate [§ 11-303] § 3-1102 OR § 3-1103 of the Criminal Law Article; and

5 (a) A seizing authority may seize a motor vehicle used in violation of [§ 11-303]
6 **§ 3-1102 OR § 3-1103** of the Criminal Law Article and recommend forfeiture to the
7 forfeiting authority if the total circumstances of the case as listed in subsection (b) of this
8 section dictate that seizure and forfeiture are justified.

9 (b) Circumstances to be considered in deciding whether seizure and forfeiture are
10 justified include:

11 (1) evidence that the motor vehicle was acquired by use of proceeds from a
12 transaction involving a violation of [§ 11-303] **§ 3-1102 OR § 3-1103** of the Criminal Law
13 Article;

14 (2) the circumstances of the arrest; and

15 (3) the way in which the motor vehicle was used.

17 (a) The chief law enforcement officer of the seizing authority that seizes a motor
18 vehicle used in violation of [§ 11-303] **§ 3-1102 OR § 3-1103** of the Criminal Law Article
19 may recommend to the appropriate forfeiting authority in writing that the motor vehicle be
20 forfeited only if the officer:

21 (1) determines from the records of the Motor Vehicle Administration the
22 names and addresses of all registered owners and secured parties as defined in the Code;
