17 18	(a) A provider shall establish an internal grievance procedure to address a subscriber's grievance.
19	(b) The internal grievance procedure shall at least:
20 21	(1) allow a subscriber or group of subscribers collectively to submit a written grievance to the provider:

subscriber or group of subscribers within 5 days after receipt of the written grievance;
