SENATE JOINT RESOLUTION

1 A Senate Joint Resolution concerning

2 **United States Constitution – Amendments Convention – Congressional Term**
3 **Limits Amendment**

4 FOR the purpose of applying to the U.S. Congress for an amendments convention called
5 under Article V of the U.S. Constitution, on the application of the legislatures of
6 two-thirds of the several states, to propose an amendment to the U.S. Constitution
7 that limits the number of terms that a person may be elected as a member of the
8 U.S. House of Representatives and a member of the U.S. Senate; and generally
9 relating to an application to Congress for a convention to propose an amendment to
10 the U.S. Constitution.

11 WHEREAS, The American people no longer favor career politicians who run for
12 reelection over and over again; and

13 WHEREAS, Members of Congress seem to care more about pandering to campaign
14 contributors and special interest groups than representing their constituents; and

15 WHEREAS, Election rules and government power have been perverted so that it has
16 become almost impossible for the people to vote their elected representatives out of office;
17 and

18 WHEREAS, 75% of the American people support term limits; and

19 WHEREAS, Congress will not vote for an amendment to impose term limits on itself;
20 and

21 WHEREAS, Article V of the U.S. Constitution allows for states to bypass the U.S.
22 Congress to propose an amendment through Convention; now, therefore, be it

23 **RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND**, That, as provided
24 in Article V of the U.S. Constitution, the General Assembly of Maryland respectfully applies
25 to the U.S. Congress for an amendments convention to be called, as soon as two-thirds of



1 the several states have applied for a convention, for the purpose of proposing an
2 amendment to the U.S. Constitution limited to setting a limit on the number of terms that
3 a person may be elected as a member of the U.S. House of Representatives and a member
4 of the U.S. Senate; and be it further

5 RESOLVED, That this application shall be considered as covering the same subject
6 matter as the applications from other states to the U.S. Congress to call a convention to set
7 a limit on the number of terms that a person may be elected to the U.S. House of
8 Representatives and the U.S. Senate; and be it further

9 RESOLVED, That this application shall be aggregated with the applications from
10 other states for the purpose of attaining the two-thirds of states necessary to require
11 Congress to call a limited convention on this subject, but shall not be aggregated with any
12 other applications on any other subject; and be it further

13 RESOLVED, That this application constitutes a continuing application in
14 accordance with Article V of the U.S. Constitution until at least two-thirds of the
15 legislatures of the several states have made an application for an equivalently limited
16 amendments convention; and be it further

3 legislative applications for a convention of the states under Article V of the U.S.
4 Constitution; and be it further

5 RESOLVED, That the Secretary of State is directed to send copies of this Joint
6 Resolution to the presiding officers of both Houses of the legislature of each of the several
7 states, with the request that it be circulated among leaders in the legislative branch of the
8 state governments; and with the further request that each of the states join in requesting
9 the U.S. Congress to call a convention for the purpose of initiating a proposal to amend the
10 U.S. Constitution as described in this Joint Resolution.
