Veterans of Foreign Wars of the United States Free State Post8950 will pursue, in collaboration with the Department of Agriculture and Natural Resources, the provision of certification and training in aquaculture operations, allowable under the GI Bill, and all necessary funding to operate an advanced food production unit (Greenhouse); therefore seeks to engage in a partnership with the Veterans of Foreign Wars of the United States Free State Post 8950 to explore the feasibility of developing and implementing an aquaculture production model that will provide educational training and development for veterans, introduction of aquaculture technology, and economic alternatives for the community.

Veterans of Foreign Wars of the United States Free State Post 8950 will additionally collaborate with an approved educational intuitions that has an established aquaculture program that has the capacity to train and certify veterans that have an interest in utilizing the developed cooperative model for distribution of the owner/operator's products from the aquaculture initiative, and other program participants, to provide the technical expertise and resources necessary to design and develop a hands on incubator program that will serve as an aquaculture food production hub; identify instruments that will address issues of financing an aquaculture production unit; develop and test advanced production processes and technologies; interact with state aquaculture coordinators to effectively promote aquaculture in Prince Georges County and the Northeast Region.
