Ways and Means

Election Law - Election Day Page Program - Establishment

This bill establishes an Election Day Page Program, the purpose of which is to (1) stimulate the interest of students in the election process; (2) provide assistance to election judges in polling places on Election Day; and (3) ensure the safe entry and exit of elderly voters and voters with disabilities from polling places.

Fiscal Summary

State Effect: The bill can be implemented with existing resources.

Local Effect: The bill is not expected to materially affect local government finances. It is expected that local boards of elections that choose to participate in the program can do so with relatively minimal costs. Revenues are not affected.

Small Business Effect: None.

Analysis

Bill Summary:

Training Program and Implementing Regulations

The State Board of Elections (SBE) (1) must develop a page training program for use by participating local boards of elections that includes the duties, responsibilities, and prohibited conduct of pages at a polling place on Election Day and (2) may adopt regulations to carry out the provisions of the bill.

Local Board of Elections Optional Participation and Implementation

A local board of elections may (but is not required to) participate in the program. A participating local board must implement or use components of the page training program developed by SBE. A participating local board may request from SBE a waiver from a requirement established under the bill. Each participating local board must (1) be responsible for the staffing of and implementation of a page training program; (2) ensure each page receives the required training before Election Day; and (3) encourage individuals at least age 16 who apply to the program to train as an election judge. An individual may not work as a page in a polling place unless the individual has completed the training provided by the local board.

Each participating local board of elections, in collaboration with the local school system, must establish a procedure for the selection of pages by the local board, and each participating local board may recognize and certify community service hours for pages.

Election Day Page Qualifications and Requirements

To qualify as a page, an individual must (1) be at least age 14; (2) apply to the local board of elections in the individual's county of residence; (3) be available to work at least one full four-hour shift on Election Day; and (4) complete the required training before Election Day.

A page may not engage in any partisan activity while working at a polling place or handle or touch a marked ballot at any time. A page may work up to two four-hour shifts at a polling place on Election Day.

Each page must take and subscribe to a written oath, which, when returned to the local board of elections, constitutes the commission of the position of Election Day Page. Each page must serve under the direct supervision of the chief election judges for the assigned polling place and assist election judges with Election Day duties, as directed.

Current Law: Under State law, Maryland residents age 16 or older are eligible to register to vote and serve as an election judge.
