#### **Baltimore County - Alcoholic Beverages - Sunday Sales**

This bill removes specified restrictions on the sale of alcoholic beverages on Sunday in Baltimore County, and generally authorizes specified license holders to sell alcoholic beverages during the same hours each day of the week. **The bill takes effect July 1, 2019.** 

#### **Fiscal Summary**

**State Effect:** None.

**Local Effect:** The bill is not anticipated to materially impact Baltimore County finances or operations. Any additional inspections can likely be handled with existing resources.

**Small Business Effect:** Minimal overall, but potential meaningful impact for licensees able to remain open on Sundays and realize additional sales.

**Bill Summary/Current Law:** The current and proposed hours of sale for specified establishments in Baltimore County are show in **Exhibit 1**.
