(I) MINOR BEHAVIOR THAT DISTRACTS FROM THE LEARNING ENVIRONMENT IN A MANNER THAT IS:

- **<u>1.</u> INTENTIONAL; OR**
- 2. INTENTIONAL AND PERSISTENT; OR
- (II) MODERATE TO SERIOUS BEHAVIOR THAT:
  - **<u>1.</u> <u>DISTRACTS FROM THE LEARNING ENVIRONMENT;</u>**
  - 2. DIRECTLY AFFECTS THE SAFETY OF OTHERS; AND
  - <u>3.</u> <u>IS INTENTIONAL.</u>

(B) (1) THE DEPARTMENT SHALL ADOPT REGULATIONS THAT IDENTIFY PROCEDURES FOR THE DISCIPLINE OF STUDENTS THAT ENGAGE IN DISRESPECT OR DISRUPTION.

(2) THE REGULATIONS ADOPTED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL SPECIFY THAT ON THE 10TH REFERRAL OF A STUDENT TO THE SCHOOL ADMINISTRATION FOR DISRESPECT OR DISRUPTION, THE SCHOOL ADMINISTRATION SHALL REFER THE STUDENT TO THE COUNTY SUPERINTENDENT FOR REVIEW AND DISPOSITION.".
