AMENDMENT NO. 1

On page 1, in line 6, after "statement;" insert "<u>repealing a provision of law</u> <u>exempting certain gifts from being reported on a certain lobbying activities report by</u> <u>individual recipient and by name</u>"; in lines 7 and 8, strike "the Ethics Counsel" and substitute "<u>each member of the General Assembly</u>"; in line 8, strike "list of names" and substitute "<u>notice regarding a certain meeting with Ethics Counsel</u>"; in line 12, strike the second "and" and substitute a comma; in the same line, after "5–607(a)" insert "<u>, and</u> <u>5–705(a)(1) and (b)(2)(x)</u>"; and in line 17, after "5–607(e)," insert "<u>5–705(c)(2)</u>,".

AMENDMENT NO. 2

On page 3, after line 32, insert:

"<u>5–705.</u>

(a) (1) <u>A regulated lobbyist shall file electronically with the Ethics</u> <u>Commission, under oath and for each registration, a separate report concerning the</u> <u>regulated lobbyist's lobbying activities:</u>

(i) by May 31 of each year, to cover the period from November 1 of the previous year through April 30 of the current year; and

(ii) by November 30 of each year, to cover the period from May 1 through October 31 of that year.

(b) <u>A report required by this section shall include:</u>

(2) total expenditures in connection with influencing executive action or legislative action in each of the following categories:

(x) <u>tickets and free admission extended to members of the</u> <u>General Assembly, as a courtesy or ceremony to the office, to attend charitable, cultural,</u> <u>or political events sponsored or conducted by the reporting entity, as allowed under § 5–</u> <u>505(c)(2)(viii) of this title;</u>

(c) (2) The following gifts need not be allocated to individual recipients and reported by name:

(i) gifts reported under subsection (b)(2)(vii) and (viii) of this section; AND

(ii) gifts reported under subsection (b)(2)(ix) of this section with a value of \$200 or less[; and

(iii) gifts reported under subsection (b)(2)(x) of this section, unless the recipient received from the regulated lobbyist during the reporting period two or more such gifts with a cumulative value of at least \$100].".

On page 5, in line 28, strike the brackets; and strike in their entirety lines 29 through 32, inclusive.

On page 6, in line 1, strike the brackets; in the same line, strike "(6)"; in line 4, after "(c)" insert "(1) <u>EACH MEMBER OF THE GENERAL ASSEMBLY SHALL</u> <u>PROVIDE AN ANNUAL NOTICE TO THE PRESIDING OFFICER OF THE MEMBER'S</u> <u>HOUSE INDICATING WHETHER THE MEMBER MET WITH COUNSEL FOR THE</u> <u>PURPOSE OF COMPLYING WITH SUBSECTION (B)(4) OF THIS SECTION.</u>
