AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and McComas" and substitute "<u>McComas</u>, <u>Arentz, Brooks, Carey, Charkoudian, Crosby, Fennell, Howard, C. Jackson, Qi, Queen,</u> <u>Rogers, Turner, Valderrama, Walker, C. Watson, and Wilson</u>"; and in line 5, strike "on or before a certain date" and substitute "<u>, beginning on a certain date; requiring at least</u> <u>certain percentages of accessible rooms in a lodging establishment to be furnished with</u> <u>a bed of a certain height, beginning on certain dates</u>".

AMENDMENT NO. 2

On page 2, in line 5, strike "ON OR BEFORE APRIL 1, 2021" and substitute "SUBJECT TO SUBSECTION (C) OF THIS SECTION"; and after line 11, insert:

"(C) (1) BEGINNING DECEMBER 31, 2021, EACH LODGING ESTABLISHMENT SHALL FURNISH AT LEAST 25% OF THE LODGING ESTABLISHMENT'S ACCESSIBLE ROOMS WITH A BED THAT MEETS THE REQUIREMENTS OF SUBSECTION (B) OF THIS SECTION.

(2) <u>BEGINNING DECEMBER 31, 2022, EACH LODGING</u> <u>ESTABLISHMENT SHALL FURNISH AT LEAST 50% OF THE LODGING</u> <u>ESTABLISHMENT'S ACCESSIBLE ROOMS WITH A BED THAT MEETS THE</u> <u>REQUIREMENTS OF SUBSECTION (B) OF THIS SECTION.</u>

(3) <u>BEGINNING DECEMBER 31, 2023, EACH LODGING</u> <u>ESTABLISHMENT SHALL FURNISH AT LEAST 75% OF THE LODGING</u> <u>ESTABLISHMENT'S ACCESSIBLE ROOMS WITH A BED THAT MEETS THE</u> <u>REQUIREMENTS OF SUBSECTION (B) OF THIS SECTION.</u>
