On page 1, in line 12, after "records;" insert "<u>requiring the Commission and the</u> <u>Comptroller to cooperate in the sharing of certain information and personnel in certain</u> <u>inspections and other activities for certain purposes; requiring the Commission and the</u> <u>Comptroller to enter into a certain memorandum of understanding for certain purposes;</u> <u>authorizing the Commission to enter into memoranda of understanding and certain</u> <u>arrangements with other governmental units for certain purposes;</u>".

On page 2, in line 10, after "<u>corrections</u>;" insert "<u>altering expiration dates of</u> <u>certain initial terms</u>; <u>altering the effective date of a certain Act</u>;"; and after line 19, insert:

"<u>BY adding to</u>

<u>Article - Alcoholic Beverages</u> <u>Section 1-321</u> <u>Annotated Code of Maryland</u> (2016 Volume and 2019 Supplement)".

On page 3, in line 1, strike "7" and substitute "<u>3, 4(a)(1), 7, and 12</u>".

THIS ARTICLE AND OTHER LAWS RELATING TO ALCOHOL AND TOBACCO, THE COMMISSION AND THE COMPTROLLER SHALL:

(1) <u>COOPERATE AND SHARE INFORMATION AND PERSONNEL IN</u> <u>INVESTIGATIONS OF LICENSED PREMISES AND OTHER LOCATIONS AND</u> <u>MATERIALS RELATING TO THE ENFORCEMENT OF THE ALCOHOL AND TOBACCO</u> <u>LAWS OF THE STATE;</u>

(2) <u>COOPERATE AND SHARE INFORMATION AND PERSONNEL IN</u> <u>OTHER MATTERS RELATING TO THE MANUFACTURE, PROCESSING,</u> <u>IMPORTATION, TAXATION, SALE, AND SERVICE OF ALCOHOL AND TOBACCO IN</u> <u>THE STATE; AND</u>

(3) ENTER INTO A MEMORANDUM OF UNDERSTANDING FOR COOPERATIVE ACTIVITIES IN INSPECTIONS AND OTHER ENFORCEMENT ACTIVITIES RELATING TO THE ALCOHOL AND TOBACCO LAWS OF THE STATE.

(B) THE COMMISSION MAY ENTER INTO MEMORANDA OF UNDERSTANDING AND OTHER COOPERATIVE ARRANGEMENTS WITH FEDERAL, STATE, AND LOCAL GOVERNMENTAL UNITS IN CARRYING OUT THIS ARTICLE AND OTHER ALCOHOL AND TOBACCO LAWS OF THE STATE IN THE INTEREST OF REDUCING DUPLICATION OF EFFORTS AND REDUCING THE OVERALL COSTS OF ADMINISTRATION OF INSPECTION AND ENFORCEMENT PROGRAMS TO THE STATE.".

On page 20, after line 26, insert:

"<u>SECTION 3. AND BE IT FURTHER ENACTED</u>, That the initial terms of the members of the Alcohol and Tobacco Commission appointed under Section 1 of this Act shall expire as follows:

- (1) <u>one member on June 30, [2021] 2022;</u>
- (2) <u>one member on June 30, [2022] 2023;</u>
- (3) one member on June 30, [2023] **2024**; and
- (4) two members on June 30, [2024] **2025**.

SECTION 4. AND BE IT FURTHER ENACTED, That, as provided in this Act:

(a) It is the intent of the General Assembly that:

(1) the transfer of the Field Enforcement Division and the personnel of the Division to the Alcohol and Tobacco Commission under this Act shall take effect not later than [July] JANUARY 1, [2020] 2021;";

in line 28, strike "MAY" and substitute "DECEMBER"; and after line 33, insert:

"<u>SECTION 12. AND BE IT FURTHER ENACTED</u>, That this Act shall take effect [June] JANUARY 1, [2020] 2021.".
