On page 2, in lines 9 and 10, strike "A RETINA OR IRIS SCAN, FINGERPRINT, VOICEPRINT, OR SCAN OF HAND OR FACE GEOMETRY" and substitute "<u>THE DATA</u> OF AN INDIVIDUAL GENERATED BY AUTOMATIC MEASUREMENTS OF AN INDIVIDUAL'S BIOLOGICAL CHARACTERISTICS SUCH AS A FINGERPRINT, VOICEPRINT, GENETIC PRINT, RETINA OR IRIS IMAGE, OR ANY OTHER UNIQUE BIOLOGICAL CHARACTERISTIC THAT CAN BE USED TO UNIQUELY AUTHENTICATE <u>THE INDIVIDUAL'S IDENTITY</u>".
